I WAS DRIVING ALONG UPPER THOMSON RD TOWARDS MARYMOUNT AND I WAS DRIVING AT THE BUS LANE. WHEN I REACHED THE JUNCTION SIN MING RD. VEHICLE B STOP A SIDE OF THE RD. I STOP DUE TO RED TRAFFIC LIGHT. WHEN THE TRAFFIC LIGHT TURN INTO GREEN, VEHICLE B STILL NOT MOVING SO I HORN HIM. VEHICLE B STARTED MOVE FORWARDS, IM FOLLOWING BEHIND OF HIM, AND VEHICLE B STILL DRIVING AT THE BUS LANE. HE DID TRY TO FILTER INTO THIRD LANE BUT COULDN'T MANAGED TO FILTER OUT, THEN HE SUDDENLY APPLIED EMERGENCY BRAKED. I IMMEDIATELY APPLIED BUT COULDN'T STOP IN TIME AND COLLIDED ONTO HIS REAR PORTION. WE MANAGED TO TAKE PHOTO AND EXCHANGED PARTICULARS. NO INJURIES INVOLVED.




