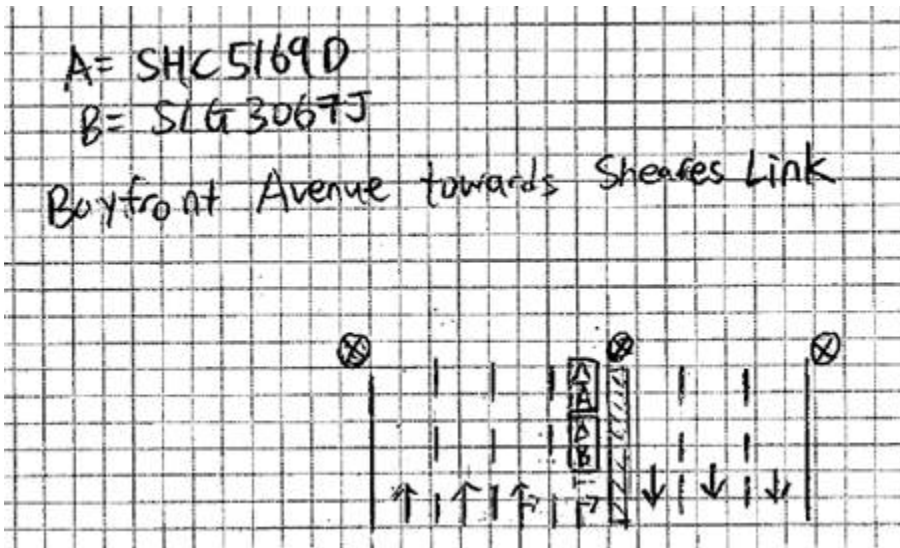
**WITHOUT PREJUDICE**
