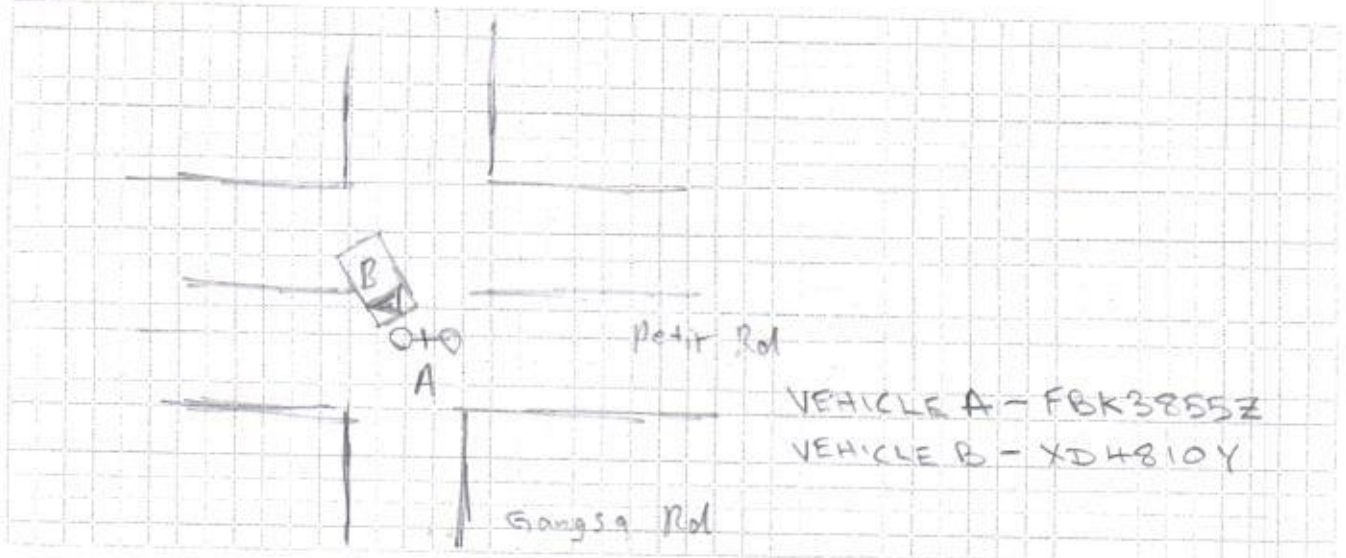

Brief Details.

On 04/07/2018 at about 1745hrs, I was riding my motorcycle(FBK3855Z) along Petir Road towards Dairy Farm Road from Hillion Mall. As I was approaching the junction of Petir Road and Gangsa Road, I noticed that there was a lorry(XD4810Y) on the opposite side of the road wanting to turn right. I could see the lorry slowing down. However, as I was approaching the junction, the lorry suddenly inched forward even though the traffic light was in my favour. I applied my emergency brakes and managed to stop. However, the lorry did not stop and went to make the right turn, colliding onto me. The lorry only stopped after making the right turn into Gangsa Road. Ambulance came down and conveyed me to Ng Teng Fong Hospital. I was granted hospitalization leave till 13/07/2018. Traffic police then contacted me to lodge a traffic accident report. My left knee cap is broken. I believed that there was an witness, to the accident, who had lodged a police report.
