We refer to the subject matter.

It was reported that the Insured vehicle was involved in a 3 vehicle chain collision and was the last vehicle and rear-ended TP vehicle.

We had spoken to the Insured Driver Mr Liang where he confirmed accident and was informed of the TP claim and liability issues on 19/07/2018 and agreed to settle the matter. A letter was sent out to the Insured to inform about the TP claim and liability. No feedback from Insured till date.


