





<p>On 28 Jun 2018, at 1745, I was traveling on the AYE towards Tuas. Near the Just before Lower Delta Flyover, after I had switch lane, traveling around 40 kph, the vehicle YN 3621T stopped suddenly. I applied brakes but was unable to stop in time, and collided with into the vehicle YN 3621T. Airbags were deployed & I suffered very minor scratches & slight burn from the deployed airbags.</p> <p>Upon getting out, found out that YN 3621T had also collided with SLQ 6033J. No injuries were reported by either drivers.</p>




