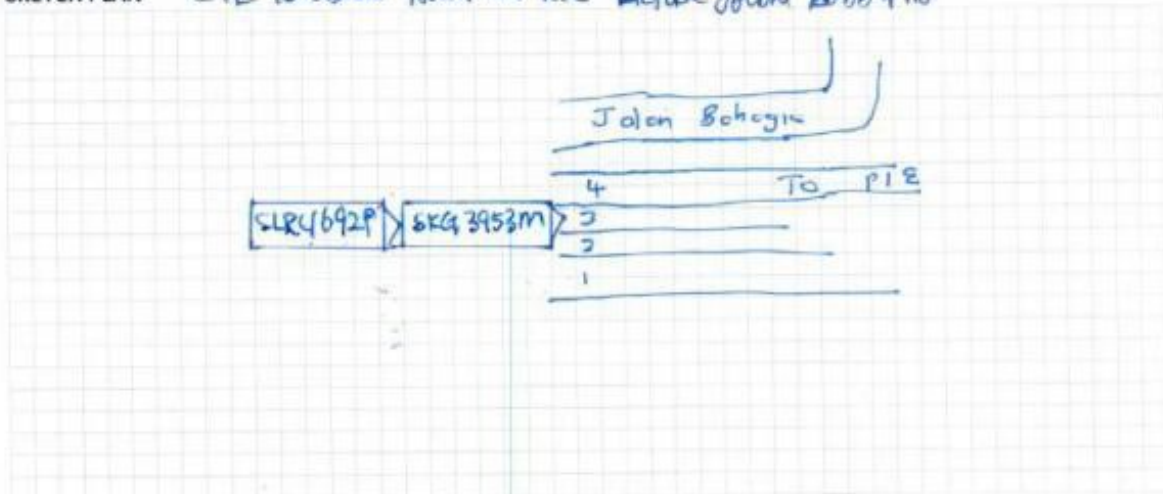

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was driving along the CTE towards Angmo Kia. Traffic was heavy but road dry. Just before the Jalan Bohogia exit at about 1440hrs, the vehicles in front of me stopped. I stopped also. I then was jolted forwards by the vehicle behind me, SLR 4692P driven by Tan Chun Hsien (57937101G). This happened on Lane 3. There were no passengers in my car or his. We next moved our car to the side of the expressway. He apologised but being a Grab vehicle, did not want to make a settlement.
