



3. LEASE RENTAL FEE

In the event, the Rental Fee remains unpaid for more than THREE (03) calendar days, the Lessor may lodge a police report as a loss of vehicle and activate the vehicle repossession team to retrieve the vehicle. The incidental cost for repossession process of a minimum SGD\$350.00 will be charged to the Lessees. In the event a Debt Collection Agency is engaged to collect all unpaid monies due to us, all such costs will be charged to the Lessees and will be included and calculated as part of the total sum of monies due from the Lessees.

4. TERMINATION NOTICE

i) The Lessor reserves the right to terminate this Agreement if the Lessees:

 a) fail to pay the lease rental fee or any other payment remain unpaid for more than 3 days after becoming due and or the Lessees knowingly or with fraud intent refuse to return the Vehicle upon the Lessor's demand;

b) commit a breach to any part of this Agreement; or

- c) does or allow to be done any act or thing which in the opinion of the Lessor may jeopardize the Lessor's rights in the Vehicle.
- Upon the termination of this Agreement, not limiting to reference to sub-clause (a) above, the Lessees agree to pay to the Lessor:
 - a) all arrears of the Rental and all other sums accrued and unpaid at the date of termination;

b) cost of all repairs required at the date of termination;


c) Penalty computed as Total Lease Rental Fee for the remaining unexpired Lease Period.

5. ADDITIONAL NEW DRIVER OR RELIEF DRIVER OR CHANGE OF MAIN DRIVER

- Additional drivers, relief drivers or a change of the main driver may be included to this contract, subject to the Lessor's approval, at an additional charge. (please refer to Annex 2)
- An administrative fee of S\$1,000.00 (subject to GST) will be incurred for any request to change or add on the Lessees particulars, change of Vehicle and additional drivers or relief drivers.
- iii) Additional named drivers can be included to drive the vehicle with prior approval from the Lessor. Any additional driver will be charged at S\$25.00 weekly or S\$100.00 monthly, inclusive of GST. This amount will be valid throughout the rental period without any cancellation.
- iv) In the event the vehicle is driven by anyone other than Lessees or without the consent or approval by the Lessor, all insurance coverage for the vehicle and 3rd party legal liability will be null and void. All such claims for damage to the leased vehicle and 3rd party property damage, medical claims or death that may arise immediately or later will be borne by the Lessees.
- v) The Lessees will be responsible to ensure the additional driver, relief driver or a new driver all possess a valid Private Hire Car Driver's Vocational License (PDVL) and approved by Land Transport Authority (LTA). The Lessees and their relief, replacement drivers is deemed to possess a valid PDVL upon signing this Agreement.

6. DEPOSIT


- The Lessees shall upon signing this Agreement pay to the Lessor a deposit (the Deposit) of <u>S\$ 6,000.00</u> as security. The Deposit shall maintain at the same amount during the Rental Period.
- ii) Brand New Vehicle is subjected to successful COE Bidding which may require up to a maximum of 03 months. In the event that the COE is unsuccessful, the deposit will be refunded accordingly without interest.
- iii) Without prejudice to the Lessor's other rights, the Lessor shall be entitled to forfeit and/or retain any part of the Deposit in the event the Lessees breaches, fails or neglects to pay any sums or charges due to or owing to the Lessor.
- iv) The Deposit will be fully refunded, interest-free only when the Lessees has fully discharge its obligations stated below by providing 30 days written notice to the Lessor after the:
 - a) Completion of 60th month of this Lease & Own Agreement.
 - b) Completion of 84th month of this Lease & Own Agreement.
- v) The Deposit cannot be contra off as part of the monthly rental fee.
- vi) In the event, the Lessees fails to turn up for collection of the assigned vehicle within 03 days from the date of the contract, the Deposit will be forfeited and the Lessor reserves the rights to claim for any contractual losses or damages from the Lessees accordingly.
- vii) The Lessor may offer the Lessees the flexibility in paying the agreed deposit sum or any balance to this in an instalment scheme. However, this scheme is offered at the Lessor's absolute discretion.
 - The refundable deposit MUST be paid to the Lessor in the following Deposit Instalment Scheme (DIS):-
 - a) an initial SGD\$1,500.00 to be paid upon signing of the Lease & Own Agreement;
 - b) the remaining deposit sum to be paid in SGD\$100.00 per week payment to commence immediately after vehicle collection and MUST be paid until the full deposit sum of SGD\$6,000.00 is reached.

7. MAINTENANCE, BREAKDOWN & EMERGENCY SERVICE & INSPECTION

- The Lessor shall at its own cost provide service and maintenance to the Vehicle at a regular interval of every 15,000KM or 6 months whichever comes first or as recommended by the manufacturer.
- ii) The Lessees shall at its own costs arrange to deliver the Vehicle at the Lessor's appointed date/time to the appointed workshop when the Vehicle requires service and maintenance. Delivery service can be arranged at a nominal fee subject to availability of man-power.
- iii) Failure to turn up for the scheduled service and maintenance work may result to damages of the Vehicle. The Lessor reserves its right to demand for the appropriate compensation from the Lessees for any repair cost resulted from the failure to turn up for the service and maintenance work.
- iv) The Lessees must make available the vehicle on or as informed by the Lessor's representative for inspection before the inspection expiry date. Failure or delay in making the vehicle available will result in a penalty of S\$200.00 being imposed by the Lessor to the Lessees and this sum to become payable immediately.
- v) The Lessees must ensure that the Vehicle has reasonable fuel, engine oil, auto-transmission oil, radiator water at all times. Failure to perform may result to damages of the Vehicle and the Lessor reserves its rights to demand the damages from the Lessees.
- vi) The Lessor shall at its own cost replace one set of tyres at an interval of every 50,000KM only. Any subsequent replacement of tyres within 50,000KM will be borne by the Lessees.
- vii) The Lessor shall at its own cost replace one set of battery at an interval of every 24 months only. Any subsequent replacement of battery within the 24 months will be borne by the Lessees.

- viii) All 24-Hour breakdown and emergency service is applicable within SINGAPORE only. All costs associated with any 24-Hour breakdown and emergency service arising from the use of the Vehicle outside Singapore will be borne by the Lessees.
- ix) 24-Hour breakdown and emergency services are extended in Malaysia but subjected to the following strict conditions:
 - a) Insurance coverage is extended to the Vehicle in Singapore and Malaysia only. An insurance EXCESS of up to S\$4,000.00 (for Singapore) and \$6,000.00 (for Malaysia) will be imposed on the Lessees for each accident and payable immediately.
 - b) MUST contact rescue personnel as provided in the vehicle front windscreen decal.
 - c) NO 3rd PARTY Towing or workshop is allowed to tow or repair the Vehicle without the official approval from the Lessor. Failing which, all such costs will be borne by the Lessees and UN-CLAIMABLE.
 - d) REPLACEMENT VEHICLE will NOT be provided for any breakdown or accident in Malaysia. However, a rental car can be provided to the Lessees at a special rate and at the Lessee's own costs.
- x) The Lessees agree that key locked inside the Vehicle, steering wheel locked, changing of a punctured tyres and stalling caused by empty petrol tank do not constitute a breakdown. The Lessees accepts a charge of S\$60.00 if the 24-Hour breakdown and emergency service is being deployed for such instances.
- xi) In the event, the Lessees request for any replacement of faulty car keys due to the Lessees' negligence, the cost for replacement will be charged to the Lessees accordingly.
- xii) The Lessor reserves its rights to reject any repair / replacement cost on the vehicle paid by the Lessees without any prior written approval.
- xiii) The Lessor reserves its rights to exchange the vehicle of the similar make / model at any time.

REPLACEMENT VEHICLE

- i) A Replacement vehicle, not necessary of the same make-and-model, may be provided by the Lessor in the event that the Vehicle Breakdown only. No replacement vehicle will be provided in Malaysia during breakdown or accident cases.
- ii) The Lessees shall be responsible for the petrol used in the Replacement vehicle.
- iii) Applicable Excess applies to the Replacement vehicle.
- iv) In the event, the replacement vehicle is not available during the vehicle breakdown, the Lessor may pro-rate the rental fee accordingly.
- v) The Lessor will not be responsible for any incidental costs, e.g. reimbursement of taxi fares etc, due to the vehicle breakdown / accident.

USE OF VEHICLE

- The Lessees may use the Vehicle for business, social, domestic and pleasure purposes. The Vehicle is not to be used, and the Lessees agrees not to permit it to be used, for any purpose for which it is not expressly designed and not to use it for driving tuition, sub-leasing, towing, racing, pace-making, or for competing in any form of motor sport or for any illegal purpose whatsoever.
- ii) The Lessees shall be responsible for the petrol, Electronic Road Pricing and parking charges and Traffic fines arising from the use of the Vehicle or any Replacement vehicle provided by the Lessor during the course of
- iii) Smoking is strictly prohibited in the vehicle. The Lessees will bear the cost of engaging professional services for removing the cigarette fumes stain in the vehicle cabin.
- iv) The Lessees accepts that the use of the Vehicle in Malaysia is subject to the Legislations of the Malaysian Government and Malaysian Road Transport Department (JPJ).
- v) The Lessees shall be responsible for the petrol, Electronic Road Pricing and parking charges and Traffic fines arising from the use of the Vehicle or any Replacement vehicle provided by the Lessor during the course of the Rental Period. This includes all respective tolls, Road Charge charges in Malaysia and all traffic related fines or summons issued by relevant authorities in Malaysia.
- vi) The Lessees MUST ensure all fines from Housing Development Board (HDB), Urban Redevelopment Authority (URA) and Land Transport Authority (LTA) to be paid immediately when notified officially by the relevant authorities. In the event, the fines remain unpaid and a notice of fine is received by the Lessor, then the Lessor reserves the right to:

- a) Furnish full available particulars of the Lessees to the relevant authorities; and
- SGD\$10.00 administration fees for each fine received.
- vii) The Lessees accepts all costs and liabilities incurred arising from the use of the Vehicle outside Singapore.
- viii) This Vehicle is allowed to be used for ride sharing purposes, Private-Hire Limousine on condition that the Lessees possess a valid Private Hire Car Driver's Vocational License (PDVL) and approved by Land Transport Authority (LTA). The Lessees and their relief, replacement drivers is deemed to possess a valid PDVL upon signing this Agreement.
- ix) The Lessees hereby indemnify the Lessor of any liability arising from the use this Vehicle which contravenes any existing or new regulations imposed by the related government regulatory bodies.

10. LESSEES'S COVENANTS

- The Lessees and Named Drivers must be between the age of 23 and 60 years old and possess a valid Singapore
 or international driving license with at least 2 years driving experience.
- ii) The Lessees agree not to:
 - a) make or permit to be made any repairs or adjustments to the Vehicle but must promptly notify the Lessor off any damages;
 - remove or deface any identification marks or plates affixed to the Vehicle;
 - c) fit any accessories to or to modify the Vehicle in any way without the consent of the Lessor; and
 - d) use or permit the Vehicle to be used or operated in a manner contrary to the Singapore Law
- iii) The Lessees agree to indemnify the Lessor against all claims arising from the use of the Vehicle.
- iv) The Hirer shall not use the Vehicle for any other commercial activity other than solely for the purposes of providing transportation services requested by GrabCar users via the Grab app. Failing which, we reserve the absolute right and option to terminate this Car Rental Agreement, forfeiting your deposit, and you shall be required to return the car immediately and you shall continue to be liable for rental due for the remaining rental term.

11. INSURANCE

- The Lessor shall insure the Vehicle against:

ii) Non-Waiverable Excess:

- The Lessees will be responsible for the full amount of the excess, subject to GST, upon per report
 of the accident;
- ii. The excess amount should be paid to the Lessor, without demand, within 48 hours from the accident date/time <u>regardless which party is at fault</u>. Failure to comply may lead to a termination of this contract, forfeit of the refundable deposit and/or any amount withhold by the Lessor. The Lessor will reserve its rights to pursue any appropriate actions to recover the excess amount if the refundable deposit and/or the monies withheld by the Lessor is insufficient to cover the excess. The Lessor has absolute right to claim the rental charges for the remaining rental period up to the actual rental period as shown in point (2) of page one(1) herein.
- Excess will only be refunded to the Lessees upon confirmation from the insurer on the percentage of liability on the Lessees

iii) In the event of an accident, the Lessees shall:

a) obtain vehicle registration numbers, names and addresses of the parties involved and of witness;

b) not admit fault or liability;

c) not abandoning the Vehicle without adequate provision for safeguarding and securing the same;

d) notify the Lessor immediately; and

e) make a police report if any party suffers injury.

- iv) A replacement vehicle can be arranged if the damage of the vehicle during the accident is claiming against 3rd parties. Otherwise, there will be NOT be any replacement vehicle for claiming against own damage and the Lessees must continue to fulfill their obligation to pay the monthly rental fee.
- v) Any accident may result to an increase in the insurance premium for subsequent years. The Lessor reserves the rights to adjust the monthly rental fee accordingly with the insurer's documentation proof.

vi) The Lessees will be fully liable for all damages for any unreported accident.

- vii) Additional of \$4,000 insurance excess per accident for any drivers under 23 years old or less than two years driving experiences.
- viii) The Hirers MUST sign up for Insurance Scheme (please refer to Annex 3) to reduce the insurance excess in the event of an accident and Roset Care Plan (RCP) or Roset Care Premium Plan (RCPP) to be read and agreed by Hirers and will form part of this agreement.

12. TRANSFER OF VEHICLE OWNERSHIP

- a) In the event the Lessees terminate this Agreement at any time before the end of 84th month, the above table will apply;
- b) Upon completion of this Agreement at the end of 84th month, the Lessees is required to submit a 30 days written notice of termination to the Lessor.
- Upon receiving the termination notice, the Lessor will then initiate Transfer of Ownership of the Vehicle to the name of the Lessee(1)
- d) Any fees or charges related to the transfer of Vehicle ownership will be borne by the Lessees.

13. FORCE MAJEURE

Although the Lessor will use all reasonable endeavors to discharge its obligations under this Agreement in a prompt and efficient manner, it does not accept responsibility for any failure or delay caused by circumstances beyond its control.

14. FORBEARANCE

No forbearance indulgence or relaxation on the part of the Lessor shown or granted to the Lessees in respect of any of the provisions of this Agreement shall in any way affect diminish restrict or prejudice the rights or powers of the Lessor under this Agreement or operation as or be deemed to be a waiver or any breach by the Lessees of the terms and conditions of this Agreement.

15. WAIVER OR SET OFF

The Lessees hereby waives all and any future claims and rights of set off against any instalment of Rental or any payment due hereunder and agrees to pay the Rental and other amounts hereunder regardless of any equity, set off or cross-claim on the part of the Lessees against the Lessor.

16. GOVERNING LAW

This Agreement shall be governed by and construed in accordance with the laws of the Republic of Singapore and all Parties irrevocably submit to the exclusive jurisdiction of the courts of the Republic of Singapore.


