Circumstances of Accident

I WAS TRAVELLING STRAIGHT ALONG PIE TWDS TUAS B4 EXIT 12 ON THE EXTREME RIGHT LANE. THE VEHICLE IN FRONT OF ME, SLF4482S WAS DRIVING ERRATICALLY, ACCELERATING, DECELERATING, TAPPING ON THE BRAKES WHEN THERE IS A CLEAR PATH INFRONT. AS WE REACHED NEAR THE DOWN-SLOPE END ON THE FLYOVER, SLF4482S E-BRAKED, WHICH CAUSED ME TO E-BRAKE ALSO. AS I WAS ON THE DOWN-SLOPE, TRAVELING AT AROUND 70KM/H, I WAS UNABLE TO STOP ON TIME AND MY VEHICLE COLLIDED INTO THE REAR PORTION OF SLF4482S. THEN THE CAR BEHIND ME, SLD270Z, COLLIDED INTO THE REAR OF MY VEHICLE. WHEN I CAME OUT TO INSPECT THE DAMAGE, I REALIZED THAT I WAS INVOLVED IN A 4-CAR CHAIN COLLISION. A TAXI, SHC5148P ALSO COLLIDED INTO THE REAR OF SLD270Z.

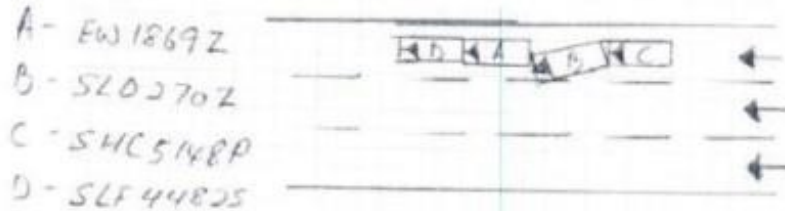

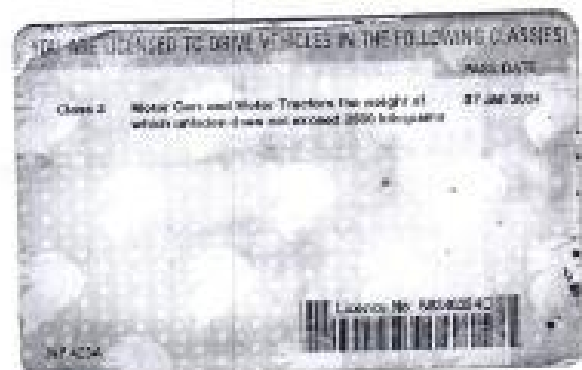
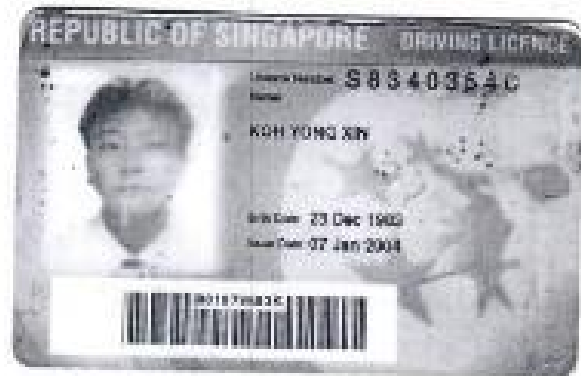
