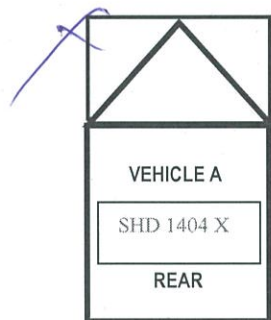

NO INJURY INVOLVED.

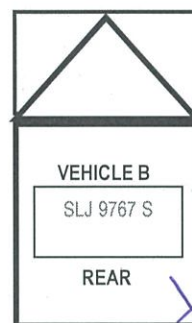

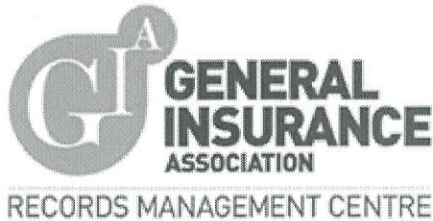
