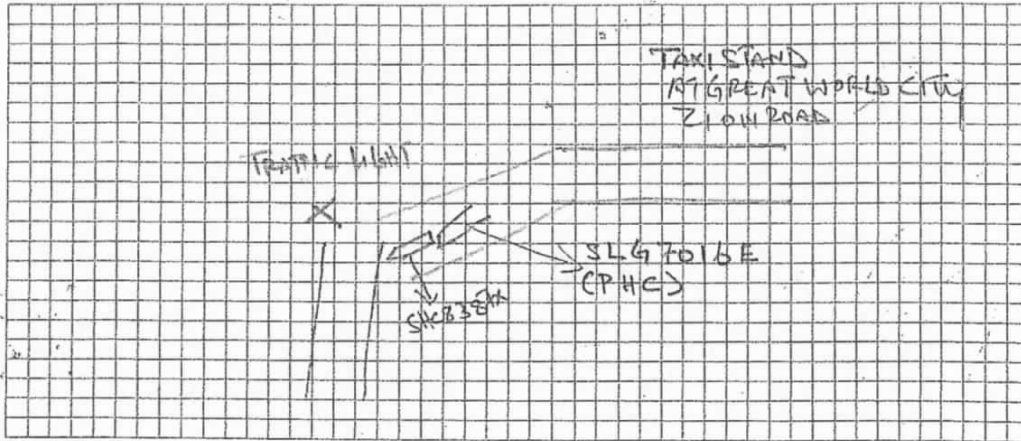

MY TAXI SHC 8387X WAS AT THE DRIVEWAY AND TRAFFIC LIGHT JUNCTION AS THE TRAFFIC LIGHT WAS AT RED I STOPPED MY TAXI. AT THAT MOMENT THIS VCH SLG 7016 (M/T ATTAGE) HIT MY TAXI FROM ^{LEFT SIDE BACK BUMPER} BEHIND. I THEN PARKED MY TAXI AT THE SIDE AND THEN TOOK PICTURES. THE OTHER VCH DRIVER REFUSED TO SHARE HIS I/D'S - AND HE SAID HE WAS TALKING TO HIS PASSENGER AT THAT TIME OF THE ACCIDENT.
