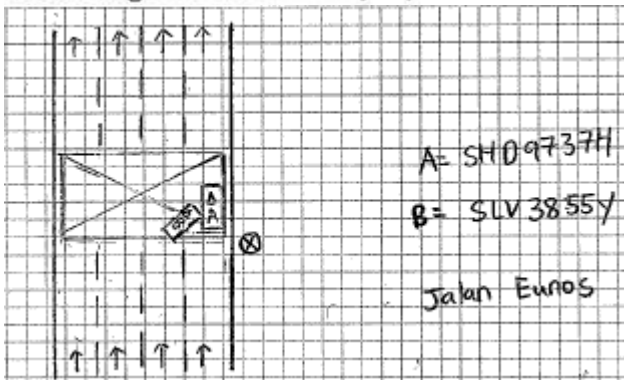

Brief Details.

I am a Transcab driver. On the 14/07/2018 at about 0922hrs, I was travelling in my vehicle (SHD9737H) along Jalan Eunus towards Still Road near the Intersection of Jalan Eunus and Jalan Awang. I was proceeding straight on the first lane located on the right. There were other vehicles moving forward in front of me at that point in time and there was also a big yellow box directly ahead of me covering the lanes of the road I was on near the said intersection of Jalan Awang. As the Traffic was moving, I proceeded forward as there was enough space for me to move. As I was doing so, Another vehicle (SLV3855Y) which was driving out of Jalan Awang on my left had collided onto the left portion of my vehicle causing damages. No one was injured during the accident however and I had alighted out of vehicles to check for damages. I had also exchanged particulars with the other driver as well. I wish state that my vehicle has a front in-car camera. I did not notice if there were cameras at the said intersection. I had followed all traffic regulations when travelling on the said road. I had visited a doc after the accident and was given 3 days of medical leave due to this incident. I am lodging this report for recording and insurance purposes.

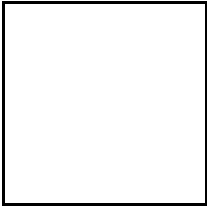
