ON 11 JULY 2018 AT 0100 HRS AT WOODLANDS CHECKPOINT TOWARDS SINGAPORE AFTER CLEARING THE IMMIGRATION COUNTER, I'M DRIVING MY VEHICLE OF MAKE HYUNDAI ELANTRA OF VEHICLE NOS SDX 6173C AND WAS HIT ON THE FRONT RIGHT FENDER WHILE QUEUING TO EXIT BY A VEHICLE OF MAKE BLACK BMW OF VEHICLE NOS SLB 8258T. THE BLACK BMW OF VEHICLE NOS SLB 8258T DID NOT SIGNAL HIS INTENTION FOR LANE CHANGE AND TRY TO SQUEEZE TO HIS LEFT AS SUCH I HAVE TO STOP MY VEHICLE TO GIVE WAY TO HIM. HOWEVER HIS VEHICLE IS TOO CLOSE TO MY RIGHT AND WHILE CUTTING INTO MY LANE, BOTH HIS LEFT FRONT AND REAR DOOR HIT MY FRONT RIGHT FENDER CAUSING DAMAGE TO MY VEHICLE. 

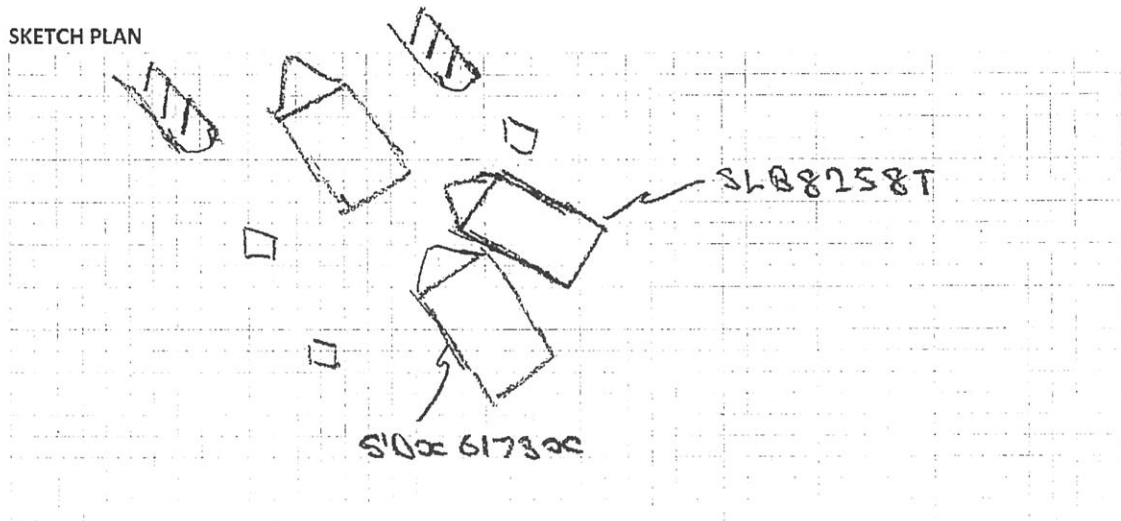
