We have reviewed the circumstances of the incident and we are of the opinion that your driver is more liable as our video footage show Traffic Light is in our OI favor. This is evidenced of video footage from our Insured. Below is a copy of our insured's accident report statement for your perusal.

Brief Details.

On 16/07/2018 at about 2230 hours, I was driving my Comfort Taxl bearing vehicle registration number SHD3331J along Bukit Batok West Ave 3 towards Bukit Batok East Ave 5. I had a passenger sitting at the front left passenger seat and two other passengers sitting at the rear passenger seat. I had stopped my vehicle at the junction of Bukit Batok West Ave 3 and Bukit Batok West Ave 6 as the traffic light was red. After the traffic light had turned green in my favor, I proceeded to drive forward. Out of a sudden, there was a strong impact on the left side of my vehicle.
