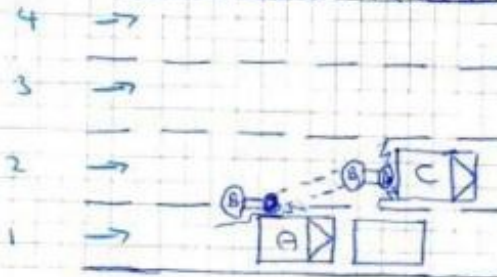

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I WAS TRAVELLING ALONG P12 TOWARDS CHANGI, I WAS ON THE EXTREME RIGHT LANE.

WHILE DRIVING STRAIGHT AHEAD, NEAR TO LORNE EXIT. THE VEHICLE IN FRONT BRAKE TO COMPLETE STOP DUE TO THE HEAVY TRAFFIC, AND SO I TOO APPLIED BRAKE TO SLOW DOWN MY VEHICLE, WHEN ABOUT TO COME TO A COMPLETE STOP. SUDDENLY I FELT A GREAT IMPACT FROM THE LEFT REAR OF MY VEHICLE.

ALIGHTED FROM MY VEHICLE AND REALIZED IT WAS A MOTORCYCLE WITH LICENCE PLATE NUMBER (FBM 1119 T) THAT COLLIDED TO MY VEHICLE AND LOST CONTROL AND HIT ONTO ANOTHER VEHICLE WHICH WAS TRAVELLING ON THE SECOND LANE.

THE WHOLE ACCIDENT FOOTAGE WAS CAPTURED BY AN IN-CAR CAMERA.
