Dear Mr Tan.

Taking into consideration the cost of a wooden body for a 14 footer lorry at \$3200, our surveyor of the opinion that this price would probably be at the lower end of the spectrum.

Also, the price quoted is probably based on fabricating a wooden body to be fitted onto a relatively accident-free lorry as stated in the quotation. Please see highlighted condition.

This quotation was probably of a verbal nature with no physical inspection of the actual accident lorry.

Judging from the accident photos taken of the lorry, additional jobs of clearing the debris, correction and straightening of vital pivotal points etc. are definitely essential in order to precisely fit the wooden body to the deck of the lorry.

Hence, considering the various differences in fitting a wooden body to a perfect lorry and a badly damaged lorry, profit margin etc. our surveyor of the opinion that the repair cost summarised in the survey report is fair and reasonable.

1. We act for AXA Insurance Singapore Pte Ltd, the insurer of motor vehicle no. YM 8358B at the material time of the abovesaid accident.
2. We enclose herewith copies of the following:-
 - a. Singapore Accident statement by the driver of YM 8358B and YK 3690J;
 - b. Survey report dated 17 October 2017 issued by RT Appraisal Pte Ltd;
 - c. Survey report dated 5 February 2018 issued by RT Appraisal Pte Ltd;
