On 230718 at 1615 HRS, I was driving a lorry SLE and I exit at 'Ponggol Road,' and turn right on to Punggol Flyover, heading towards Seng Kong.

The Traffic Light was Red and all vehicles were at a complete stop. Both vehicles (SLE620S) and (EN2712H) were in the middle lane. However, Melin Ang who was driving (SLE620S) was turning right towards SLE while I was intending to go straight towards Seng Kong- When the traffic light turn green it was our right of way, all cars are able to go straight or turn right. However, there was a lorry in the yellow box blocking the first (right lane). Melin Ang took off when the traffic light turned green and I am broke in the middle of the yellow box as she was unsure of her turning radius. I wasn't able to brake in time when she broke and my car (EN2712H) collided into her's (SLE620S)

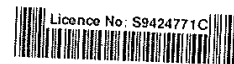
