To: Officer-in charge,

I, Ang Teck Gee (hirer's name) NRIC S016696/C, of vehicle D42184

would like to share my experience of the accident/ incident as follows:

Today 19/7/18 was my servicing. I Reported to loyang workshop at 0840 hrs for my Servicing. I reported my bonnet support was faulty. Around 1116 hrs I colladed my vehicle. My first trip was from Changi Airport to Jurong west. During my trip to Jurong west passing Jurong town Hall exit, I felt the aircon was not cold but also I realised Smoke was coming out from the bonnet. From the first lane I had slowly change lanes to stop at the road shoulder. Another taxi driver came to help me take out my fire extinguisher but the same time my vehicle caught heavy fire. Another passerby assisted me to call Civil Defense to assist putting out the fire. My Passenger in the taxi was Not injured. From the time I collect my vehicle from loyang workshop I did not face any loss power or saw any indicator light on.
