We refer to the above matter.

It was reported that Insured vehicle encroached into the TP's lane resulting into the accident. A copy of TP video footage is attached for your reference.

A letter was sent out to the Insured company to notify TP claim and NCD issues. No feedback received till date.

As such, in view of TP video footage, liability may not be to our insured's favour and we have to settle the claim from the TP vehicle and the damages sustained to TP vehicle were consistent to the nature of the accident.
