Hi Sirs,

May I seek your assistance to perform a detailed mechanical inspection of the 13 vehicles below:

a) Case: IAFP-IB-20180706 Mechanical Inspection of Tipper Truck; XD2023R (TP/IP/36553/2018)

b) Case: IAFP-IB-20180706 Mechanical Inspection of Lorry; YN5405M (TP/IP/36553/2018)

On 20 June 2018 (Wednesday) at or about 6.52 p.m., the Accused was driving the company's motor lorry, YN 5405 M, on the left lane of the 3 lanes road along Tanah Merah Coast Road towards Aviation Park Drive. While travelling straight, the Accused collided into the rear of motor lorries, GBC 2374 T, YN 3089 E and a tipper truck, XD 2023 R, which were stationary along on the left lane. Earlier, the tipper truck broke down along the left lane due to damages to the rear left tyre axle. The driver then contacted the company who send two company's lorries to the scene for repairs. The Deceased sustained severe multiple injuries and was pronounced dead at the accident scene by the attending paramedic at 7.16 p.m.

On 30 June 2018 sometime before 1.04 a.m., the Malaysian trailer, JNQ 8386 (B1), was travelling along centre lane of the 3 lanes road at Woodlands Crossings after the Sultan Iskandar CIQ (Malaysia's Checkpoint) towards Singapore Checkpoint while the Malaysian lorry, JRV 1328 (B2), was travelling in the same direction along the 1st lane. While both were travelling side by side, B2 suddenly veered to the right towards the centre divider. B2 then drove through the opening along the centre divider and into the opposite direction; towards Malaysia Checkpoint, against the flow of traffic. On the same day, he succumbed to his injuries and pronounced dead in the hospital at 2.11 a.m by Dr Ebuna.
