

# (a) Case IAFP-IB-20180504-Mechanical Inspection of Motor Car, SKD5410R (TP/IP/25859/2018)

On 1 May 2018 (Tuesday) at or about 1.06 a.m., the Deceased was driving his motorcar along East Coast Parkway Expressway towards Airport, 3.5 KM, lamp post 447F on lane 1 of 3 lanes when the Deceased was believed to have lost control of his motor car, resulting in the motor car veering to the right, collided onto the flower pots before toppling to its right. Due to the accident, the Deceased was pronounced dead at scene at 2.14 a.m. by the attending paramedic, WO Choo.
