ON 26/07/2018 AT ABOUT 1530HRS, AT ALONG PIE (TUAS) BEFORE CTE (CITY) EXIT 15A. I WAS TRAVELLING ON LANE 2 AND MY FRONT VEHICLE SLOW DOWN AND STOP DUE TO HEAVY TRAFFIC. HENCE, I FOLLOWED SUIT AND CAME TO A COMPLETE STOP. SUDDENLY, I HEARD A LOUD BANG FROM BEHIND AND THE IMPACT FORCED MY VEHICLE A TO MOVE FORWARD TO HIT ONTO THE REAR PORTION OF VEHICLE C. WHEN I ALIGHT, I REALISED IT WAS VEHICLE B WHO HIT ONTO THE REAR PORTION OF MY VEHICLE A CAUSING DAMAGES TO MY FRONT AND REAR PORTION OF MY VEHICLE. IT WAS A CHAIN COLLISION OF TOTAL 3 VEHICLES INVOLVED.

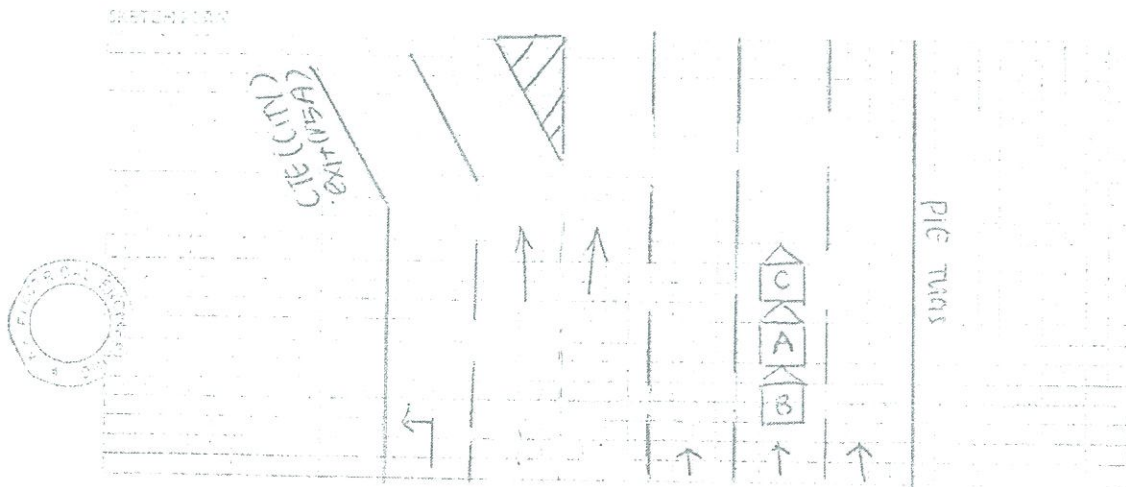
