

# Driving in Singapore: Converting a Foreign Driving Licence

If you are a Singapore citizen or permanent resident, you can drive in Singapore only after you obtain a Singapore more than 12 months. A Singapore driving licence is required after 12 months. A foreigner above 18 years of age and holding a Work Pass/Dependent Pass/Student Pass may drive in Singapore with a valid (class 3, 3A or 2B) foreign licence, for a period of not

driving licence. You must convert your foreign driving licence to Singapore driving licence as soon as possible if you want to drive in Singapore.

New Singapore citizens and permanent residents must convert their foreign driving licences within three months of

obtaining citizenship or permanent resident status.


