We refer to the above matter.

Third party reported that accident happened at Newton Flyover. There was no details on how the accident happen. Based on third party sketch plan, it seems like OID changed lane and hit onto his car.

OID reported that third party cut into his lane and resulted the accident.

There was no video footage from both parties.

Based on OID scene photo, the position of third party vehicle remained on lane 2 after collision which suggests that third party was on lane 2 before collision. Otherwise he should have remained on lane 3 after side swipe. The vehicle sustained denting indicate that it has received impact force from another party involved.

The above are merely an observation without any concrete evidence produced by either party. Therefore, we would like to propose 50/50 settlement.
