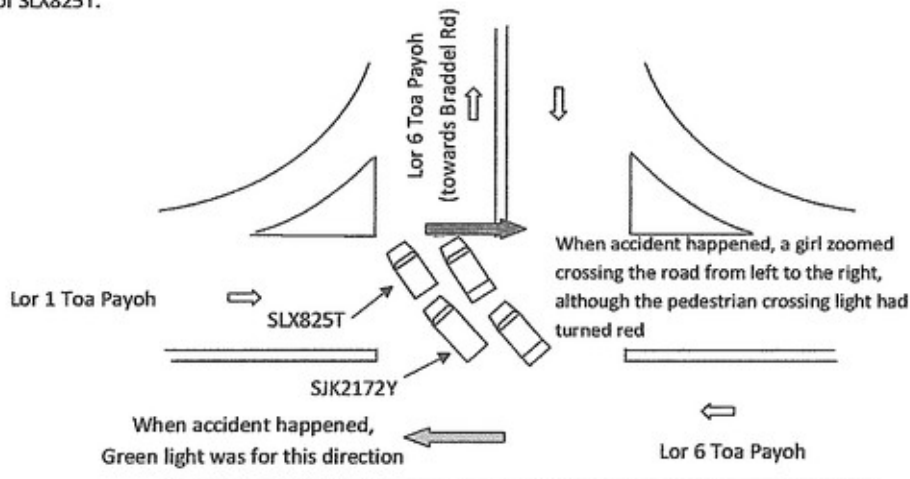

RE: ACCIDENT INVOLVING SJK2172Y & SLX825T AT THE JUNCTION OF LOR 6 TOA PAYOH AND LOR 1 TOA PAYOH ON 29th JULY 2018

The accident involving SJK2172Y and SLX825T on 29th July 2018 around 12:30 noon happened at the junction Lor 6 Toa Payoh and Lor 1 Toa Payoh.

My husband, Mr. Rudy Mulyadi (I/C : S7382158D), was driving SJK2172Y (Toyota Wish) on Lor 6 Toa Payoh waiting for the green light to turn right to Lor 6 Toa Payoh (Braddel Road direction). SLX 825T (VW Golf) was in front of my car SJK2172Y. When the traffic light turned green to our favor and the pedestrian crossing light turned red, all the cars waiting for turning right started moving. Then suddenly SLX825T (VW Golf) in front of my car jammed the brake, due to a girl zoomed crossing the road. My husband didn't have enough time to brake in time, and my car SJK2172Y hit the rear bumper of SLX825T.
