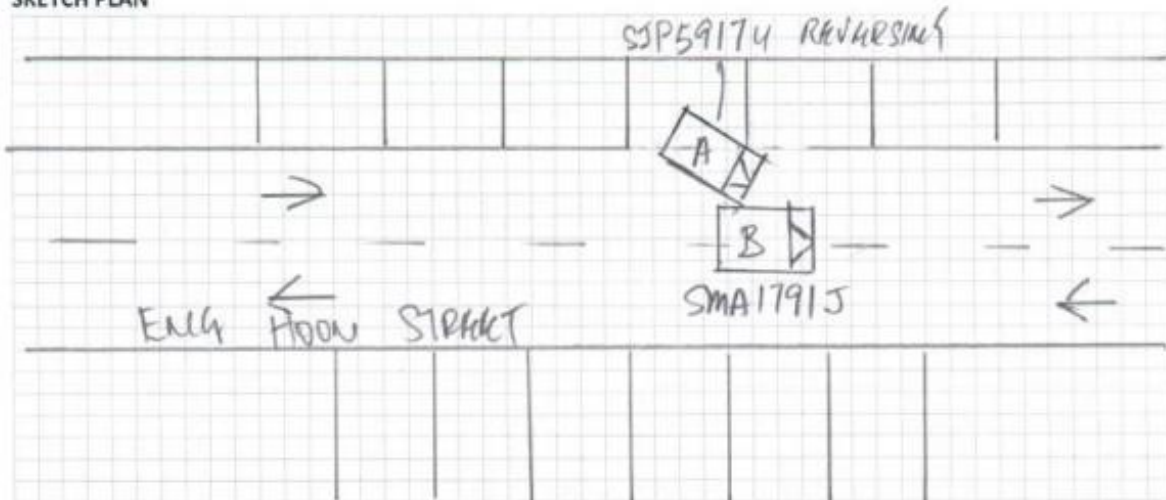

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT PARKING LOTS

While using a low speed to reverse into the car park lot, a red car came from behind and cutted into the opposite lane to overtake my car. The red car dashed passed my car at a high speed and scratched the front right corner of my car.

After the accident, scratches, black marks and red paints were left on the top right corner of my car.
