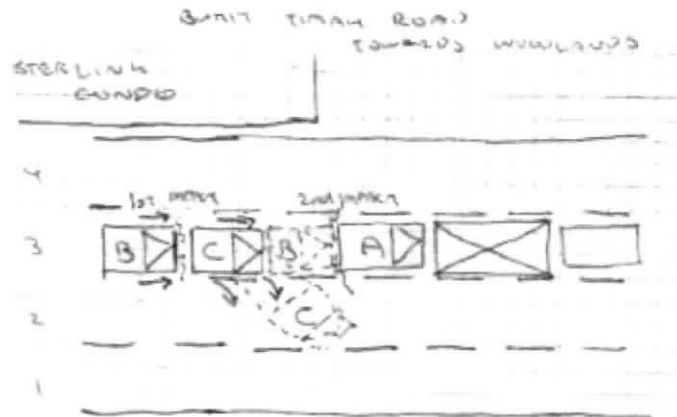

WHILE PASSING BY STEVEN CONDO ON M3 LEFT, AND
