ON 30/07/2018 @ 1610HRS, I WAS DRIVING MY TAXI (SHD 1479 E) TRAVELLING ALONG BEDOK NORTH AVE 2 - ON A SINGLE LANE OF DUAL CARRIAGE WAY.

I STOPPED MY TAXI AS ANOTHER VEHICLE WAS STATIONARY - BOARDING PASSENGERS.


WHILE STATIONARY, SUDDENLY I FELT AN IMPACT FROM MY RIGHT.

WHEN INSPECTED, I DISCOVERED THAT VEHICLE B ( SH 8873 C - COMFORT TAXI ) WHICH WAS APPROACHING FROM THE REAR - WAS SQUEEZING THROUGH MY RIGHT & COLLIDED ONTO THE RIGHT REAR OF MY TAXI.

DUE TO THE IMPACT, MY TAXI HAD DAMAGES ON THE RIGHT REAR PORTION & VEHICLE B HAD DAMAGES ON THE FRONT LEFT PORTION.
