#### Circumstances of Accident

REFER TO POLICE REPORT - T/20180730/2085 LODGED AT JURONG WEST NPC. ON 30/07/2018 AT ABOUT 1105HRS, I WAS DRIVING MY LORRY V1) YN5875P ON THE RIGHT LANE ALONG INTERNATIONAL ROAD TOWARDS JOO KOON CIRCLE. UPON REACHING THE T-JUNCTION OF INTERNATIONAL ROAD AND SOON LEE ROAD, I WANTED TO MAKE A RIGHT TURN ON TO SOON LEE ROAD. AT THIS POINT IN TIME, I WAS THE THIRD VEHICLE QUEUING UP TO MAKE THE RIGHT TURN HOWEVER SUDDENLY, THE VEHICLE V2) GBC7757P IN FRONT OF ME SUDDENLY STOPPED DUE TO THE VEHICLE AT THE MOST FRONT WHO CAME TO A STOP AS THE TRAFFIC LIGHT TURN RED. I WAS UNABLE TO REACT IN TIME THUS COLLIDED ONTO THE REAR PORTION OF V2. THE FRONT PORTION OF MY VEHICLE SUSTAINED A DENT AND THE REAR PORTION OF V2 SUSTAINED A LIGHT DENT. I ALIGHTED FROM MY VEHICLE AND TO MAKE A CHECK AND OBSERVED THAT V2 HAD COLLIDED WITH ANOTHER VEHICLE IN FRONT OF HIM. I ALSO MAKE A CHECK WITH THE DRIVER OF V2 AND HE INFORMED THAT HE IS NO INJURED. BOTH OF US EXCHANGE PARTICULARS AND LEFT THE SCENE LATER.

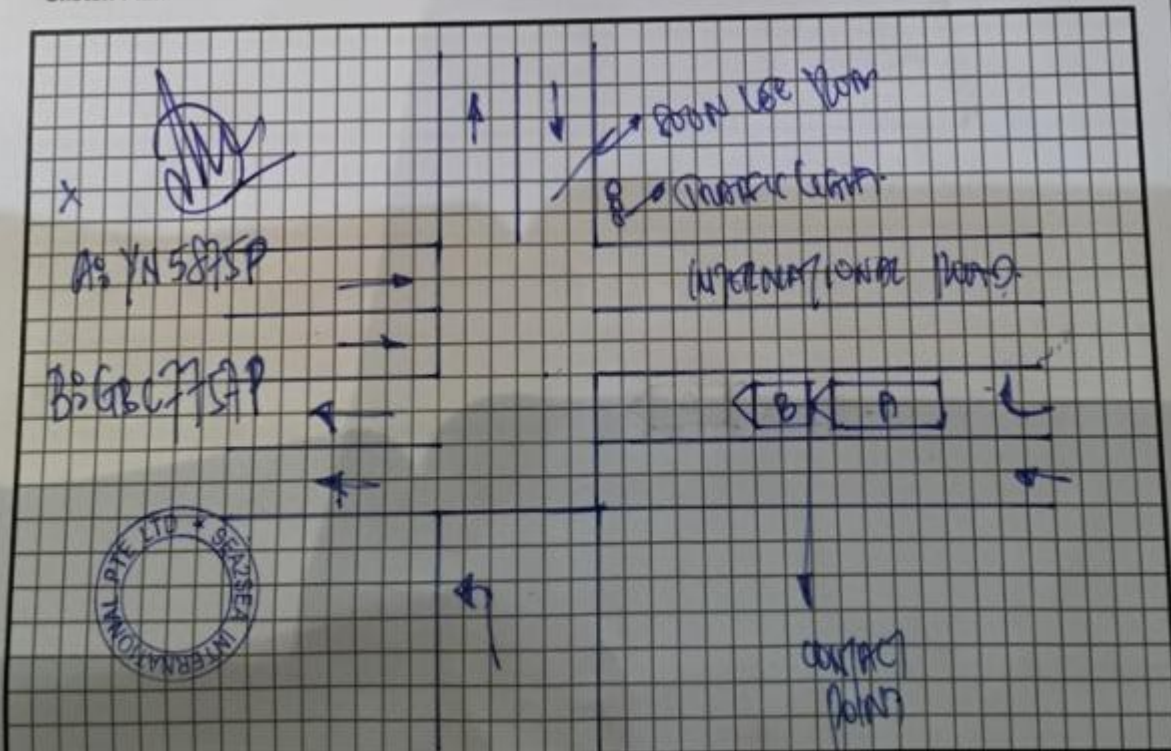

**CONTINUATION OF REPORT**

**Brief Details.**

On 30/07/2018 at about 1105hrs, I was driving my lorry V1) YN5875P on the right lane along International Road towards Joo Koon Circle. Upon reaching the T-junction of International Road and Soon Lee Road, I wanted to make a right turn on to Soon Lee Road. At this point in time, I was the third vehicle queuing up to make the right turn however suddenly, the vehicle V2) GBC7757P in front of me suddenly stopped due to the vehicle at the most front who came to a stop as the traffic light turn red. I was unable to react in time thus collided onto the rear portion of V2. The front portion of my vehicle sustained a dent and the rear portion of V2 sustained a slight dent.

I alighted from my vehicle and to make a check and observed that V2 had collided with another vehicle in front of him. I also make a check with the driver of V2 and he informed that he is not injured. Both of us exchange particulars and left the scene later.

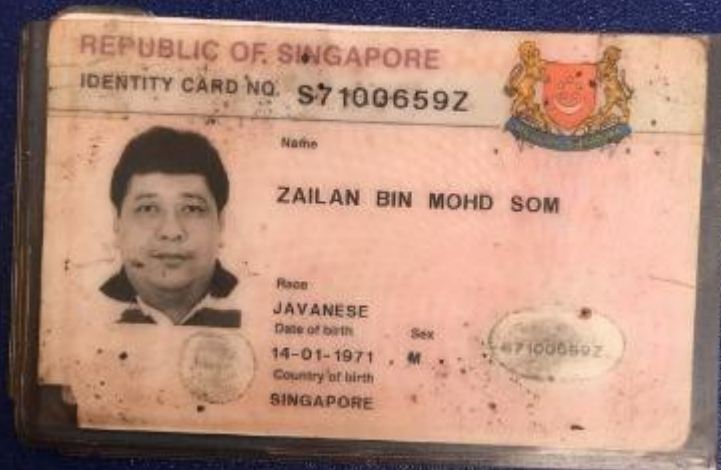
