DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 1 August 2018 @ 3:30pm, I was driving along PIE (towards Changi Airport) lampost (691), suddenly I saw the front vehicle, SLM 9865B jam brake suddenly, I was at a safe distance following behind, I did managed to brake instantly but due to the sudden jam brake, unfortunately I did not managed to make a complete stop which is why I gently bump on the back of SLM 9865B. There are photos to proof that the back vehicle shows no signs of dents or damages only visible slight scratches.

The strange thing we (all involved parties) realized, the moment we stopped at the side to take down our particulars, one of the driver involved (first car) passed his "workshop" Namecard around. Somehow we find it strange as well. The first car involved did a sudden lane change and cut into the lane and did a sudden jam brake, not deliberately jamming on the brakes or engineer accidents by intentionally damaging vehicles, therefore we suspect it might be a case of motor insurance fraud.

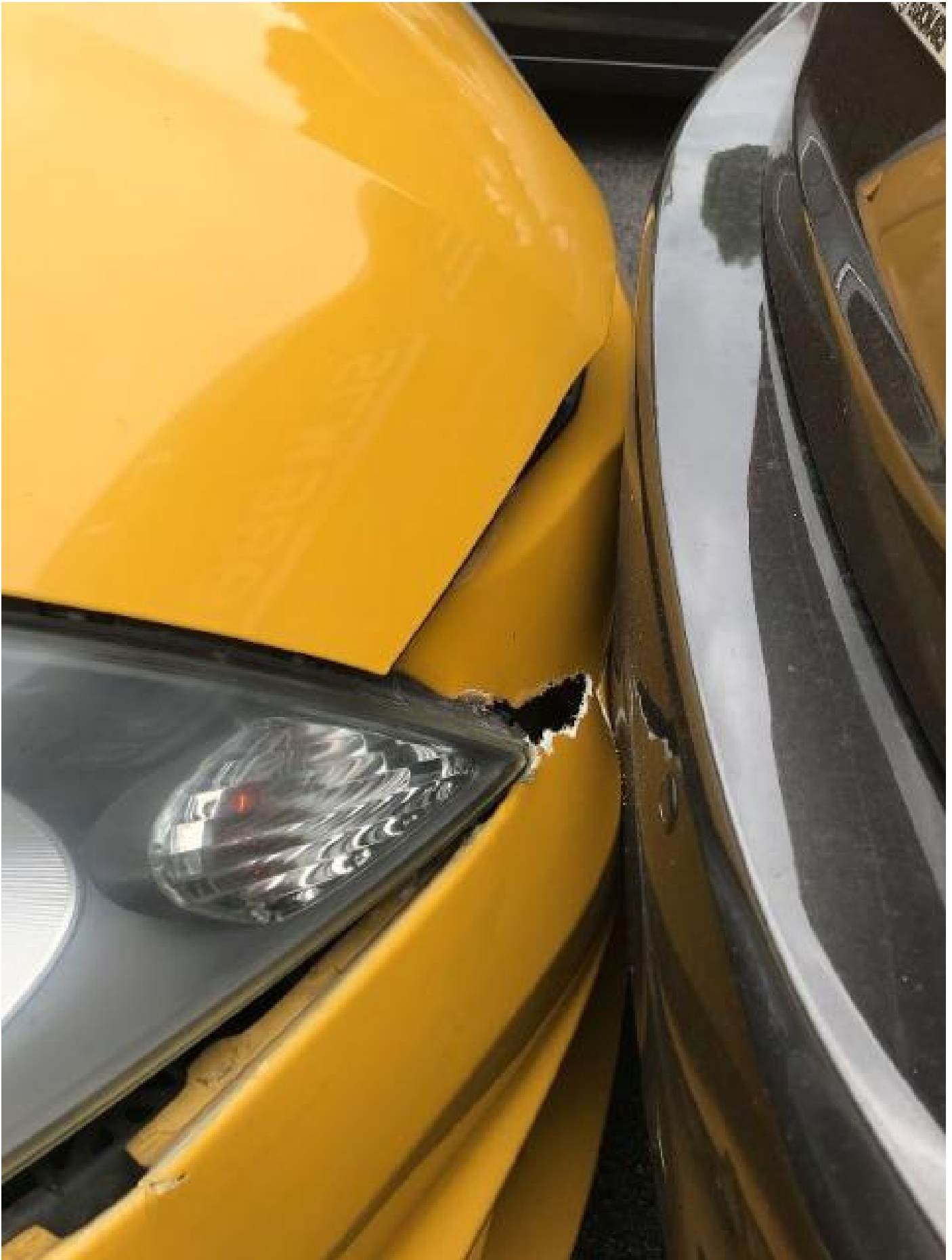

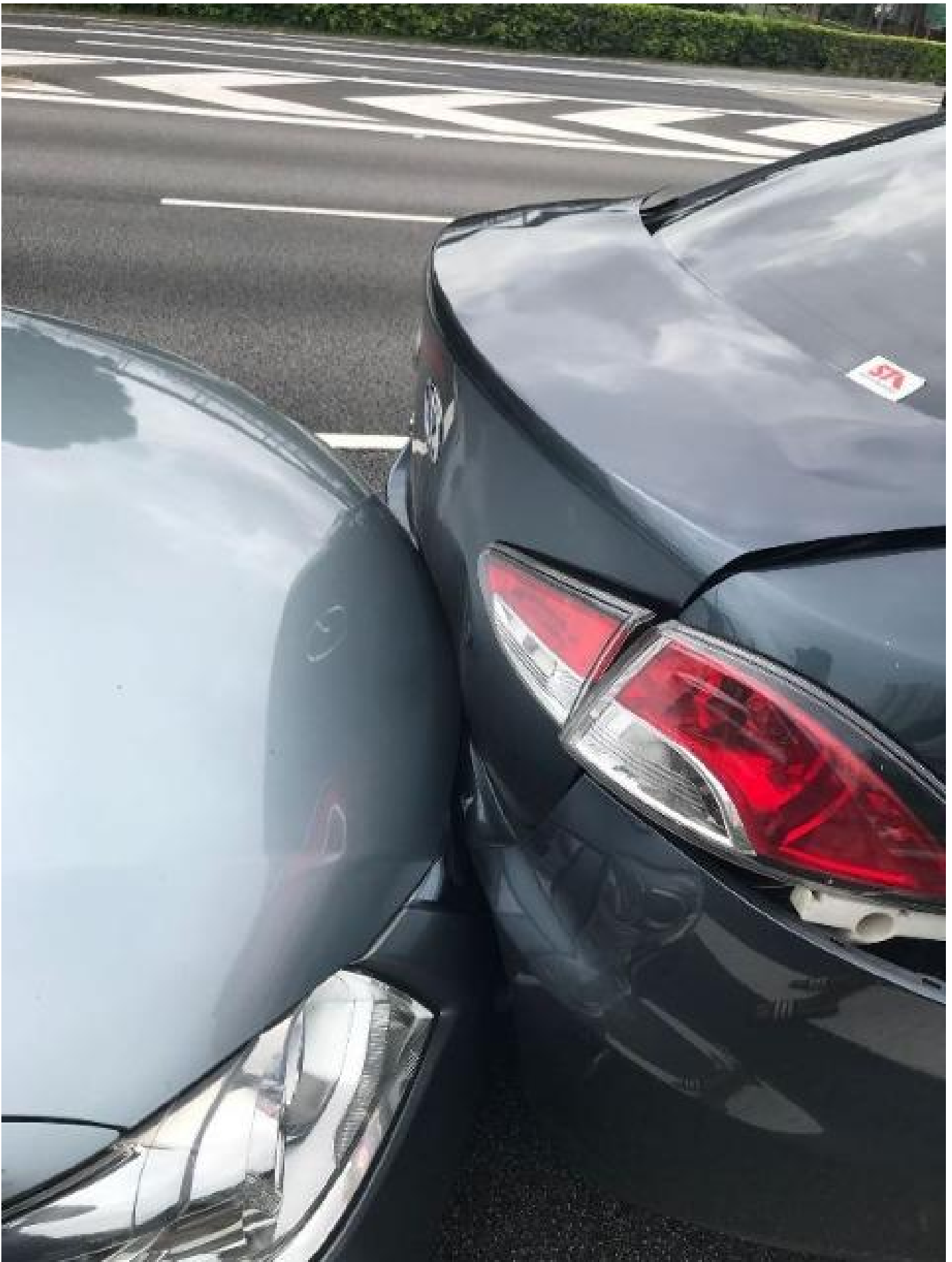
