Brief Details.

Happened on a dual carriage way along Simei Avenue, after Changi General Hospital before ITE College East at 0853hours.

I was driving on Simei Avenue on the way to send my son to work. Upon stopping behind a car on a red light, i realised the car behind, SLK3042J was driving towards my car in an extremely fast speed. I realised he might not be able to stopped in time and I released my brake to inch forward as a defensive driving to prevent collision by giving him more braking distance.

I felt a jerk and heard my car rear collision warning sound off but I am not aware if the jolt was due to collision or because of the sudden brake after I inched forward. While I look at the rear mirror, the driver gave a sign and waved his hand signalling that there was no collision. As my son was rushing to office and I am unsure if there was a collision, and the driver did not alight, thus, I moved off. Upon reaching my destination, I've realised my rear bumper was slightly dented and paint was chipped off and scratched.

I did not report within 24 hours as I was having a 2 week Medical Certificate and was unable to walk to make a police report. I was only been informed this online reporting service by my son today, therefore, I am making my report today.

There was no pedestrian crossing at the accident site and I have videos of the collision which is more than 2mb.
