Brief Details.

On 01/08/2018 at about 1150hrs, I was driving my vehicle SKZ4923T from Johor towards Singapore, in lane 2 of the causeway, my vehicle was in the car only lane and the traffic was slow moving. After crossing to Singapore side of the causeway, I felt an impact on the left side of my vehicle.

After the accident, I alighted from my vehicle and discovered that a vehicle, JSP3935, from lane 3 (car and motorcycle lane) cuts the chevron marking and merge into my lane and collided onto my vehicle. We exchanged particulars, the driver then informed that me to claim from his insurance and we left the scene. After which I went to my IDAC for damage assessment and I was advise to lodge a Traffic Accident Report.

The damages to my vehicle are scratches and dents from the front left bumper all the way to the rear left tyre including both left door.
