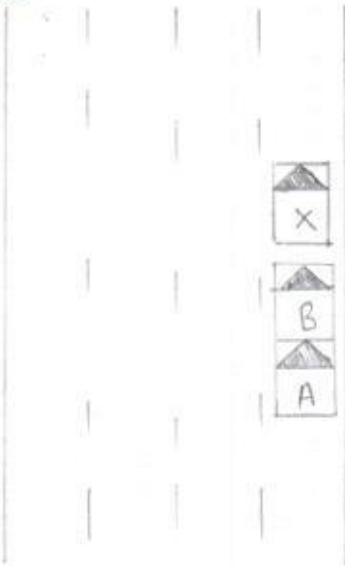

This is an accident report which happened on 28 July 2018 evening at around 2150 hour.

In summary,

What happened: An accident involving my car knocking into the car in front of me

Where it happened: PIE toward Changi; most right lane just before Jalan Euno Exit

When it happened: 28 July 2018, around 2150

Who was involved: BMW SLM5571M (Mr Khairudin 96721771) and Kia SJL2182M (Mr Hoong 83889792), Toyota Altis SJY2131S (Jonatons 96784637)

How it happened: The car in front of me had abruptly came to an immediate stop on the most right lane in PIE and I knocked into the back of his car. The details are as follows.

I was driving on the PIE heading towards Bedok North to drop off 2 grab passengers I had picked up early. Traffic conditions were smooth and I observed no signs of slowing in the rightmost lane. The road was dry as well. I was cruising at 75-80km/h keeping at about 3 cars length distance away. Suddenly, the BMW car SLM5711M came to an immediate stop with no prior braking lights displaying or intermittent braking signals. My immediate reaction was to floor my brakes pedal. At that moment, as I was on my brakes, I could not feel any strong braking resistance and it led me to move forward; it resulted in knocking into the BMW SLM5571M.

I was not hurt in the process and I immediately asked if both my passengers who were seated at the back, hurt in the accident. One of the passengers seems hurt herself in the head or face. I assumed she must have hurled forward and hit into the front seat in the process. The other passenger showed me his pinky fingernails were bent as it was longer than average. All of us got out of the car subsequently. Before they left with a taxi driver behind who offered them a ride to their destination, I repeatedly asked if they had any major injuries. Both of them replied they were good.

Next, the driver, Mr Khairudin of SLM 5571M had called for an ambulance as it seems that 2 out of 4/5 of his passengers seem to be hurt in the process. As such, the ambulance, EMAS tow service, AETO auxiliary traffic police as well as NPC police were activated and involved at the scene. I went to seek out what happened in the front.

The 2 cars that were involved in the accident were

1. BMW SLM5571M (Mr Khairudin 96721771)
2. Kia SJL2182M (Mr Hoong 83889792)
3. Toyota Altis SJY2131S (Jonatons; myself 96784637)

According to what they had accounted to me, the Mr Hoong; the driver of Kia car SJL2182M had to jam brake as the car in front of him had stopped suddenly as well thus he braked in such that BMW SLM5571M had to come into a complete stop immediately as well. The car in front of SJL2182M was not present at the scene and it appears that Mr Hoong did not knock into the car in front of him. I also noticed that Mr Hoong car Kia

SJL2182M had Private Hire Driver label and he had 2 passengers. If I recall correctly, he mentioned he was driving his passengers to their destination as well, commercially as a Private Hire driver.

As to why he was involved, appearing to assist in the collision as his car was not damaged, I am not sure in that aspect. I strongly believe it had something to do with his abrupt braking that led to the BMW SLM5571M having to brake in that manner. As such, Mr Hoong came out of his car to explain. In addition, I did notice there was some intense explanation between Mr Khairudin and Mr Hoong upon the initial aftermath phase of the accident. From the appearance of the car, Mr Khairudin did not seem to have knocked into Mr Hoong car. Mr Hoong was also busy taking pictures at the scene as well. Mr Khairudin also appeared to be more concern with Mr Hoong involvement in the accident as well as his passengers well being.

During the situation, I was told by the AETO auxiliary police officer that I had to make a police report. Subsequently, I was told by the NPC police officer that I did not have to make a police report, just accident report to my insurer. According to the ambulance medics, I visually observed that they did some checks on the passengers and as to what diagnostic made, I am unsure about it. The EMAS eventually towed away my vehicle to the nearest carpark as it seems unfit to drive further. I was told by the EMAS operator that the tow service was free of charge and I signed off the vehicle removal record.

After reporting to Tribecar hotline operator earlier, I was instructed to inform them of where my car would be towed to by EMAS. The car was eventually towed to Block 12 Euno Crescent open carpark. The Tribecar assigned tow operator was subsequently informed of my exact towed location. I was instructed by him to lock my car and place the keys hidden on the right wheel. After which he mentioned that I am able to leave for home.
