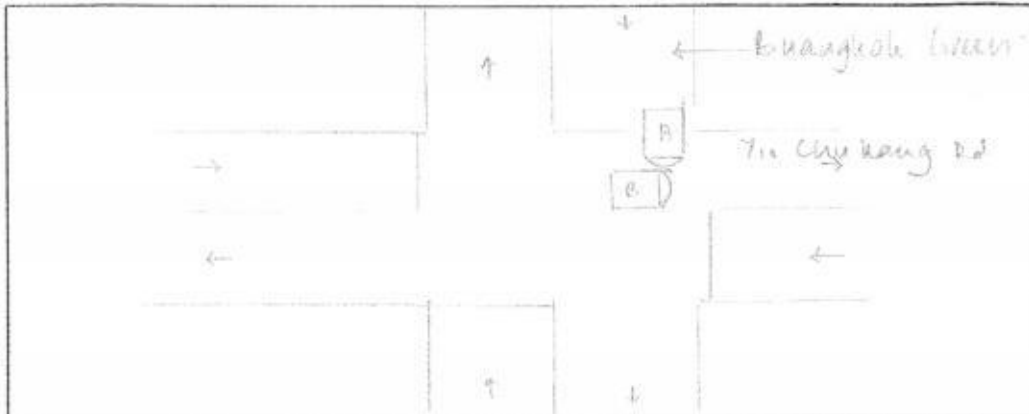

**Brief Details.**

On 09/07/2018, at around 0035hrs, I was driving along Buangkok Green towards Ang Mo Kio Avenue 5. When I was passing the junction of Buangkok Green and Yio Chu Kang Road, a taxi, driving along Yio Chu Kang Road towards Upper Serangoon Road, drove up and hit my vehicle, at around the right headlight area of my vehicle. I spun to the left, and ended up on Yio Chu Kang road. I was shocked and in a daze due to the impact. Around five to ten minutes later, the Police and ambulance arrived. The Police talked to me and my passenger briefly, and then we were checked and conveyed to Tan Tock Seng Hospital by the paramedics.

I suffered a dislocated left index finger, abrasion on both knees, and contusion of chest wall, and was given 7 days MC.
