STATEMENT OF WITNESS

I, S9644588A, LCP QUAK SHOU KANG, was on a detail to the Kallang Sea Training Centre for the purpose of Out-Pro at the Dragon Boat Association. While entering the roundabout from Stadium Drive and negotiating the left bend into Nicoll Highway, there was a heavy vehicle in front of my vehicle. The left side of the heavy vehicle was mounting the curb as the turning bend was too narrow for it to pass through. Therefore I was focusing on the heavy vehicle in front of me and was afraid he might suddenly stop. After we were about to leave the bend, I felt a bang at the rear of the GP car. Since I was preoccupied with the heavy vehicle in front of me, I was more focused on it compared to what was behind me. In order not to stop the traffic flow at the bend, I decided to drive ahead to stop the GP car and get down to confront the driver of the vehicle behind me. The vehicle that hit the GP Car was the same type of lorry as the one in front of me previously.

When I confronted the driver, he told me that his left side of the vehicle was mounting the curb and therefore he had to drive the vehicle more to the right of the bend in order not to make the mounting worst. Therefore his front left side of the vehicle banged onto the rear right side of the GP car.

No one was injured in this incident. That is all I have to say.
