

I started my car's engine and was about to move out of the carpark lot which is next to the air pump located within the premises of the said Esso station when a Toyota Wish came close to my car and turned towards the 'air pump. The Toyota Wish was between my lot and the nearest petrol pump/kiosk. The driver of the said Toyota Wish waved to indicate for me to move out of my carpark lot.

As I was about to clear the rear end of the Toyota Wish, a TransCab taxi bearing license plate number SHC5920B sped into the petrol station from the entrance and zoomed straight towards the empty carpark lot next to the petrol pump/kiosk nearest to the Toyota Wish and my car. Seeing the speed the TransCab was carrying, I tried to brake to avoid him but he still sped straight towards the empty lot and turn slightly towards my direction in order to get into the lot, resulting in my car crashing into the doors of the left side of his taxi. Upon impact, the taxi driver didn't stop immediately but continued to drive forward, dragging the front end of my car with his taxi. He only came to a complete stop when his taxi was almost fully into the said empty lot. This indicated the excessive speed he was carrying into the tight confines of the said petrol station.

As I got out of my car, I noticed the time as around 1634 hrs.

After I got out of my car, I asked the said taxi driver why he didn't stop as I had the right of way. He said he was unsighted by the said Toyota Wish plus he was rushing to the toilet.

After both of us had finished taking photos of the accident scene, I asked him thrice to take out his NRIC and Driving License so that we can exchange particulars, thrice, he refused to show his documents, citing there was no injury involved and hence he don't have to furbish his particulars.

With that, as I was about to get into my car, I noticed a surveillance camera of the petrol station pointing exactly at where the said accident happened. I then got into my car and moved out of the petrol station and that was the last instance I had my encounter with the said taxi driver.
