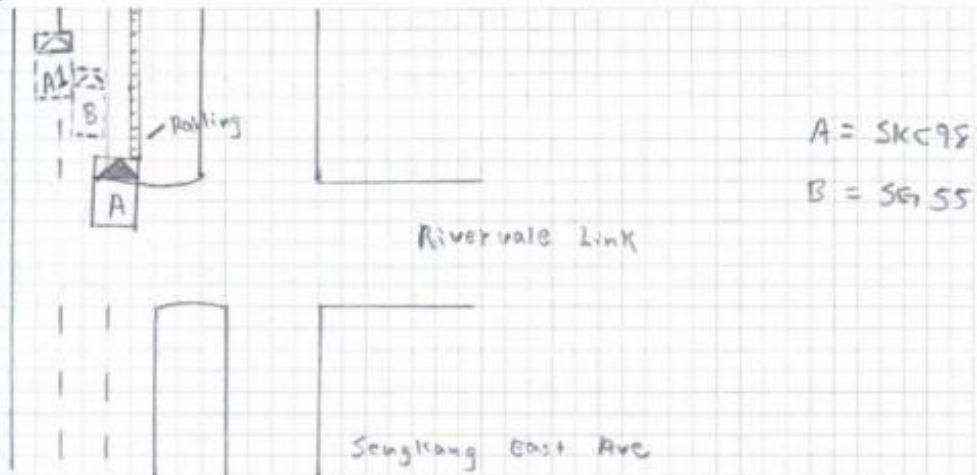

Brief Details.

On the 9/8/2018 at around 10.25pm, I was driving my car bearing registration number SKC9834E Chevrolet Cruze grey in colour along Sengkang East Ave heading towards Sengkang East drive. The road is a two lane and I am driving on the right side. Near to lamppost 20, my car was too close to the right and my front right wheel went up the divider and hit the railing. I maneuvered down to the road and manage to drive to the left lane of the road but can barely past the right lane. However I have to stop the car as the tyre came off the rim. I came out from the car and called for help. The railing at the divider was dented. A few minutes later, a bus bearing registration number SG5545A was driving along the same road tried to maneuver pass my car. However when doing so the bus had collided to the right side of the car. The bus had grazed the right side of the bumper and tail light. I am not aware if at one is injured
