It was reported that the Insured vehicle turned too early before the junction when collided to the TP vehicle. A copy of TP video footage was uploaded for your reference.

We had spoken to the Insured Driver Mr Ganesan and he was informed of the TP claim and liability issues.

In view of the above, we are of the view that liability is not to our Insured's favour and the damages sustained to TP vehicle were consistent to the nature of the accident.
