We refer to the subject matter and to the assignment dated 15th August 2018 of Third-Party's request to do Direct Settlement with our Principal, Lonpac Insurance Bhd.

This is a conflicting version where both drivers reported that the other vehicle cut lane that resulted into this accident. Both parties have no further evidence to support their claim.

As such, in view of conflicting versions, for changing lane, we propose for a 50/50 settlement to the TP repairer.

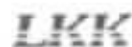

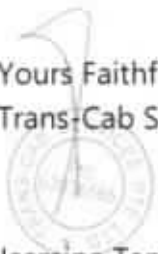
