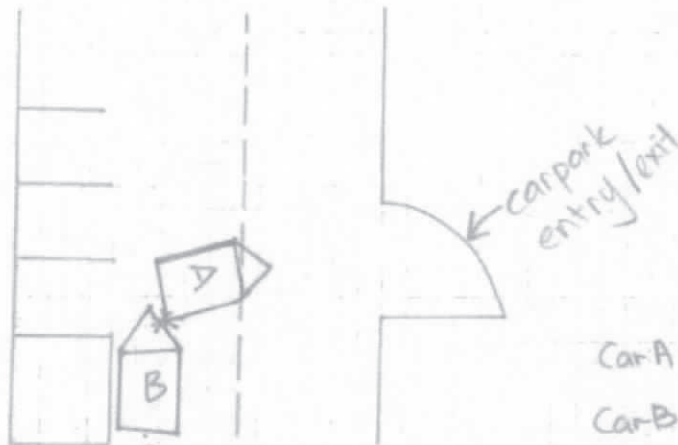

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

Driver of said vehicle bearing number plate 'GBH5208U' was driving in the carpark of BKK 1st bedok South with his hazard lights on. I then exited the parking lot that I was in to leave the place and was driving behind the other party with and still saw that his hazard lights were still on. After a short distance, he suddenly turned right, towards the entrance of a multistorey carpark, and stopped. Upon seeing this I stopped my vehicle too. The other party then suddenly changed to reverse gear and started reversing. As I was behind him I realised that I was ~~too~~ in front of an empty lot and quickly turned him and changed to reverse gear to try and avoid a collision. I could not reverse too quickly as there was another vehicle behind me and the other party collided into me. I have video footage of the incident from my dashcam.
