

On 17/5/18, I was sending my rider and his friend to Kallang
Wave Beach (Stadium Road)
At the roundabout towards Stadium Place, I followed the
GPS direction to keep left lane and to take EXIT at EXIT 3.
When I turned out, the road was clear.
I was halfway past EXIT 3 when without warning or
indicating by signalling to turn, (COMFORT Taxi SHD 62111)
cut into my lane from the right and hit the right side
of my front bumper.
