



CONTINUATION OF REPORT

Brief Details.

On the 18/08/2018 about 5.05pm, whilst I was driving my vehicle bearing registration plate number SGK9542C on the second lane along SLE from Woodlands towards CTE around Mandai Avenue. I remembered that the first lane was closed as they were conducting road works by LTA. A vehicle parked along the first lane inside the barricaded first lane suddenly drove out onto the second lane. This caused on coming vehicles to brake suddenly, I was unable to react in time and my vehicle collided with a vehicle in front of me bearing registration plate number SKN4827B. The vehicle was drove by Mr Hussain Bin Abdul Rashid (S006524G). None of both parties suffered any injuries. There was no damages on our vehicles as well.

I realized that Mr Hussain is a private hire car as he was ferrying a passenger that time. We heard the passenger saying that he was okay but Mr Hussain kept insisting that he made a claim against us. Mr Hussain also claim that he will make a police report against us. 
