BEFORE THE ACCIDENT, AS YOU CAN SEE ON THE ILLUSTRATION PROVIDED, THERE ARE 2 (TWO) LANES. ON THE LEFT-SIDE LANE, THERE WAS A TRUCK AND BEHIND, OUR COMPANY VAN. ON THE RIGHT-SIDE LANE, THERE WAS A WHITE CAR AND THE CAR WITH VEHICLE #SLJ3599A. AS WE ARE EXITING TOWARDS AYE SLOWLY DUE TO TRAFFIC, THE CAR WITH VEHICLE #SLJ3599A SUDDENLY CUT THROUGH MY SIDE OF LANE TO FOLLOW THE TRUCK AHEAD AND IN THAT MOMENT, I ACCIDENTALLY HIT ITS LEFT REAR BUMPER. 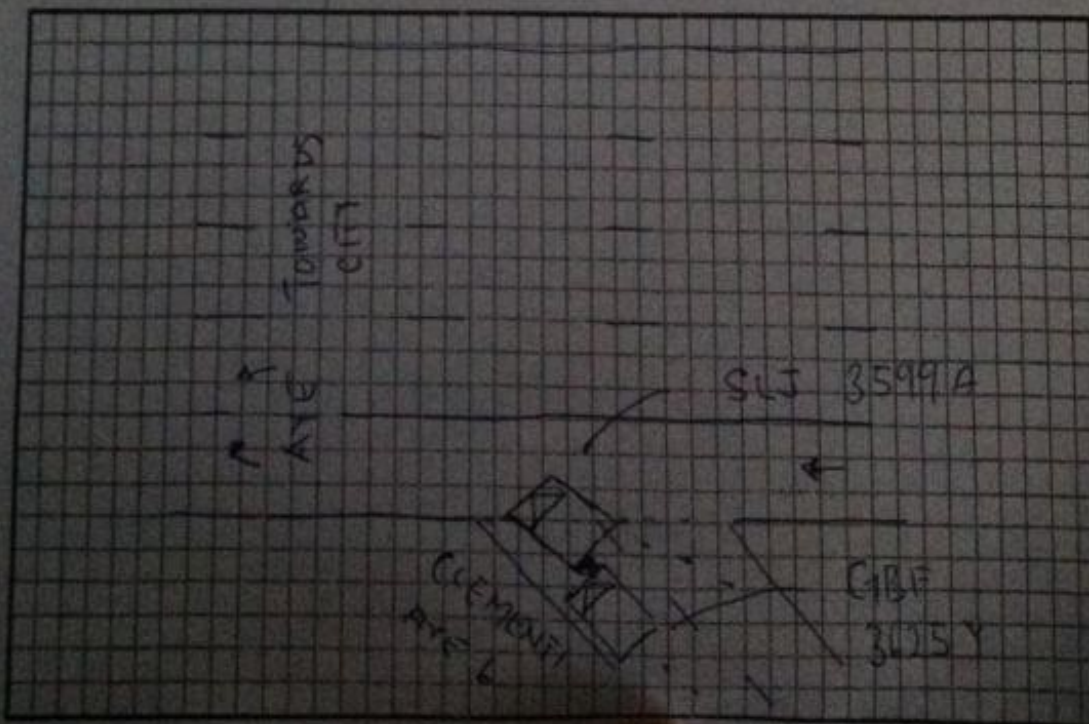

## ACCIDENT REPORT

Location of Accident: Clementi Avenue 6 exit towards AYE

Date of Accident: 20-August-2018, 03:55PM

I was driving our company van with vehicle # GBF3625Y on Clementi Avenue 6 exit on 28 August, 2018 at around 03:55pm.

Before the accident, as you can see on the illustration provided, there are 2 (two) lanes. On the left-side lane, there was a truck and behind, our company van. On the right-side lane, there was a white car and the car with vehicle # SLJ3599A.

As we are exiting towards AYE slowly due to traffic, the car with vehicle # SLJ3599A suddenly cut through my side of lane to follow the truck ahead and in that moment, I accidentally hit its left rear bumper.
