

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 28/7/18 I return home to park my car at Cairnhill Residences Basement 1 car park lot No 41, at about 5:00pm. On 29/7/18 at about 10:00am I went down to drive my car and I noticed that it was hit by an unknown vehicle. I reported to the security of my estate to check on the CCTV. I drove off then and when I returned the same day, I was told that a Limo Taxi, a white one, hit my car while reversing in the car park. I was told that the taxi came to pick up a passenger from the next block from the view of another CCTV in that block, the taxi driver, after hitting my car, drove off to another block and came down to inspect his own car before the passenger came down. When the passenger came down, the taxi driver drove off without reporting to the Management Security. The security then on the next day spoke to the passenger who's staying at Cairnhill Residences and obtain the taxi license plate no. The management office then wrote a email to Lid and Comfort Celgro to report the hit and run case. I was told to wait for response but 2 wks then and no response. I decided to make a police report as the Management Office cannot review the information to me but only to the police.
