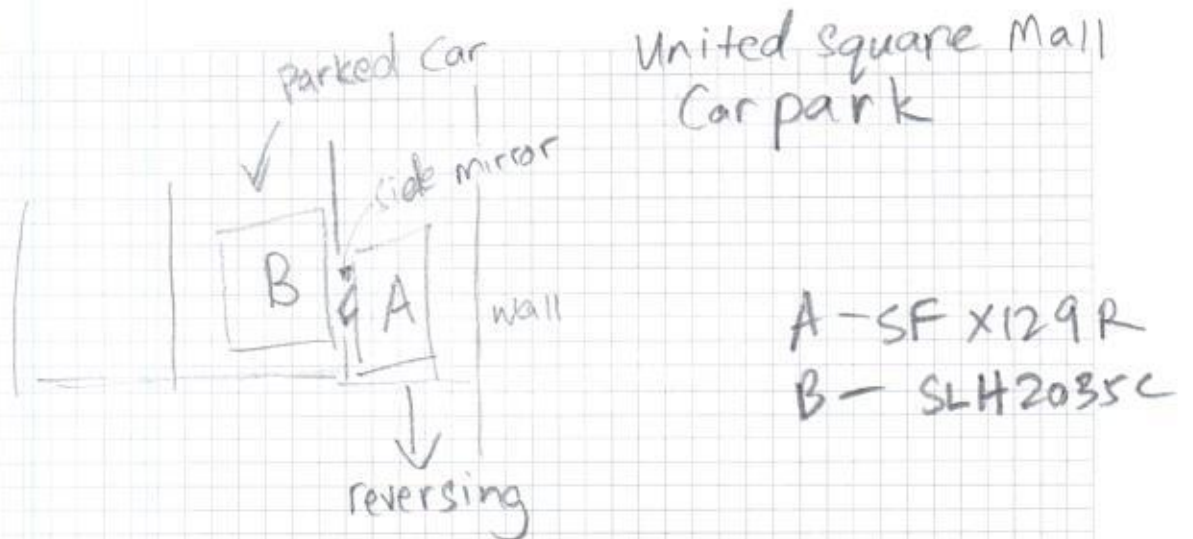

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

My Vehicle, vehicle A, was reversing from a corner parking lot at United Square Carpark and the side ~~in~~ left side mirror of vehicle A had accidentally hit the side mirror of vehicle B.
