USE OF CAR AGREEMENT ("AGREEMENT")

 Subject to your agreement to the terms and conditions set out herein, we, Mishi Auto Pte Ltd (Company Registration No. 201702092W), a company incorporated in Singapore with its registered address at 36 Sungei Kadut Avenue S(729661) ("Company"), authorizes you to use the following motor vehicle owned by the Company ("Vehicle") on the terms and conditions set out herein:

(a) Make and model: Toyota Wish 1.8(b) Registration number: SJN4998C

(c) Colour: Grey

- You shall use the Vehicle for the sole purpose of providing the services under the service agreement with GrabCar ("Service Company"), which is in the business of providing car sharing services in Singapore whereby customers are able to book cars and be driven to their specified destination in return for a fare determined by the Service Company.
- The term of this Agreement shall commence and end on the following dates:

Commencement date: 2018-08-13 ("Commencement Date") Expiry date: 2019-02-12 ("Expiry Date")

This Agreement may be terminated early in accordance with the Standard Terms (as defined below).

In the event that this Agreement is terminated early for any reason whatsoever, you acknowledge and agree that the Deposit (as defined below) will be not refunded by the Company to you, and in the event that you have not paid the Deposit in full, you shall make payment of any shortfall in Deposit to the Company immediately.

4. In consideration for the use of the Vehicle, you shall pay to the Company, and the Company shall be entitled to, a facilitation fee of SGD65 per day ("Facilitation Fee") commencing on the Commencement Date and ending on the date on which this Agreement expires or is terminated.

As a matter of goodwill, the Company will waive the Facilitation Fee payable for the Commencement Date.

- On the Commencement Date, you shall place with the Company a deposit amounting to SGD500 ("Deposit"). The Deposit may be refunded to you only in accordance with the specific circumstances specified in the Standard Terms.
