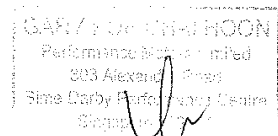

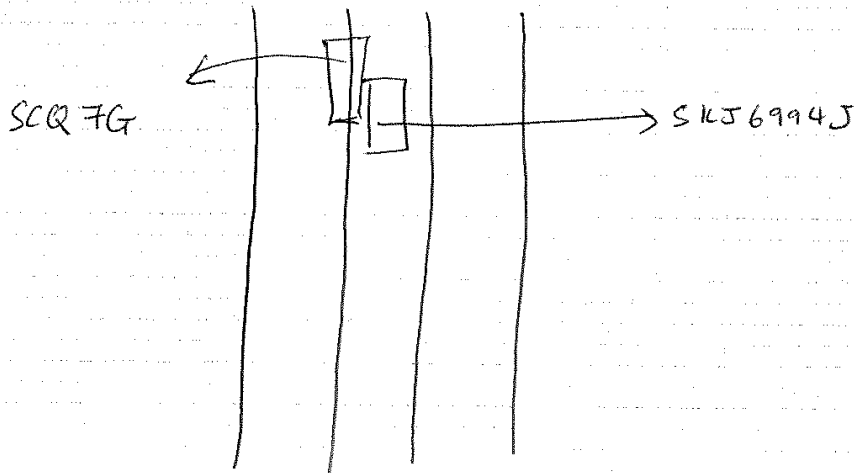

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

This incident occurred at Commonwealth Avenue West at about 9.15am on 28 Aug 2018.

I had filtered from the extreme right lane into the middle lane. I had already changed lane, when car number SCQ 7G cut into my lane from the lane to my left. This resulted in SCQ 7G bumping against the front left side of my car. Appears that the driver did not check for vehicles on his right before he changed lanes and this he bumped the left front side of my car while he was effecting his lane transfer at quick speed.

The driver of the other car, Mr Tay Kwang Jin together with his granddaughter stopped to exchange particulars with me. However, they only gave me a photocopy of Mr Tay's driver's licence. No telephone numbers were exchanged and they claimed that Mr Tay did not have his AIR I Cam with him. Both spoke in aggressive tones.

I used my handphone to record the video footage from my car camera (Motorola S/N MDC 107C006341)

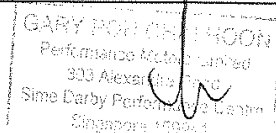
