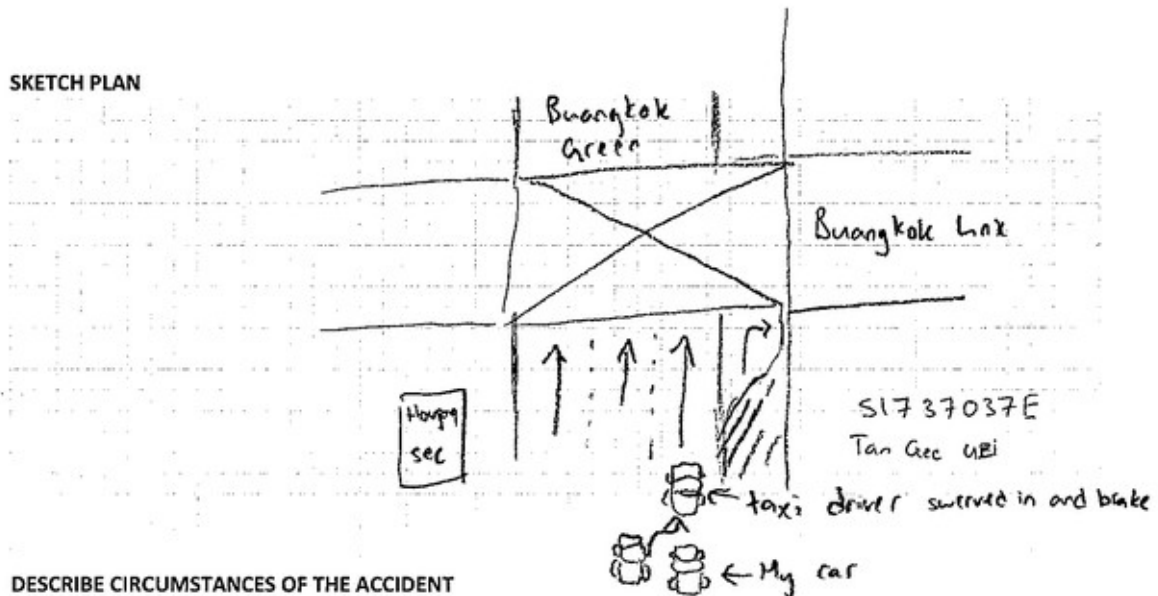

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

Location of Accident: Buangkok Green turning right into Buangkok Link.
Weather condition : Heavy Rain
Vehicles involved : Only taxi 1 taxi and my car.
Time of accident : 9.30pm
I was driving on the first lane at 40km/h. The next 30m will be the right turning lane towards buangkok link. The taxi driver swerved in from the 2nd lane and slammed his brakes. There were no obstacles or vehicles in front of him. It is not justifiable for him to jam brake and come to a stop in the middle of the road. There was not enough time for me to react due to poor visibility and the unexpected cutting into my lane and stopping.
I hit the rear of his taxi, lightly causing a slight bump in his metal bumper and some scratches on the plastic side. I checked that there were no obstacles in front of him that would cause him to brake suddenly. When I asked him why he swerved into my lane and braked, he said "yes i come into your lane because I also want to turn right at the junction". When I asked told him there was no reason to brake and stop, he had no proper answer.
Luckily I reacted quickly enough, no serious injury caused and only minor damage to our vehicles. His inconsiderate and reckless driving could have caused other road users terrible injuries
