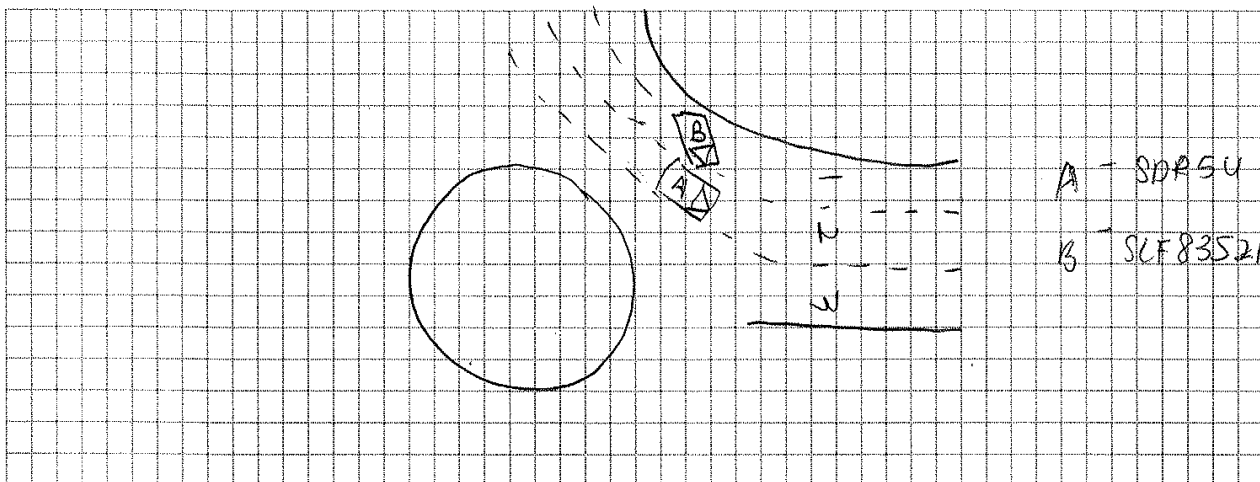

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

Exit A/E toward Pioneer North Road using Pioneer Circus. When in Pioneer Circus. I was at the most extreme right lane, while the other party was at the extreme left lane. As I was making my exit out of Pioneer Circus towards Pioneer North. In order for me to be in line with the road towards Pioneer North and not making another Roundabout, I should change my lane to the left. As I was changing my lane, there was no signal being lifted up. Upon changing to the left, My car and the other party car brushed against each other. To not to disrupt the traffic I ~~drive~~ drive the vehicle to the side of the road, while the other party park its car at the middle of the road. This accident result in dent & scratches on my car, while scratches can be seen on the other party car.
