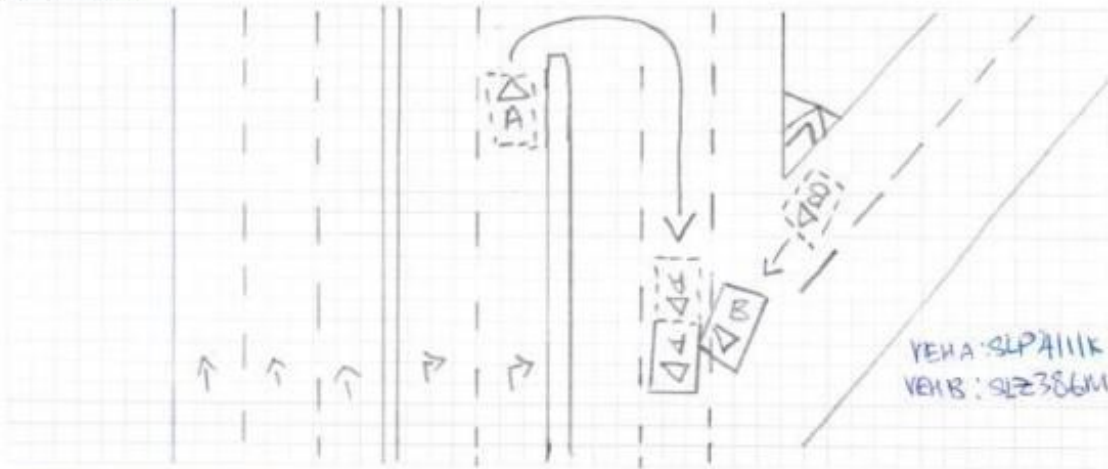

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

ON THE STATED DATE AND TIME, I WAS DRIVING MY CAR (VEH A: SLP411K) MAKING A U-TURN ON ALEXANDRA ROAD. THE GREEN ARROW APPEARED AND I PROCEEDED TO MAKE A U-TURN. AFTER I HAD COMPLETED MY U-TURN, I FELT A GREAT IMPACT ON MY LEFT REAR OF MY VEHICLE. I ALIGHTED TO REALISED THAT VEH B (SLZ386M) HAD SWERVED ONTO MY LANE AND COLLIDED ONTO THE LEFT SIDE OF MY CAR AFTER HE HAD TURNED RIGHT FROM THE FILTER LANE.

I WISH TO STATE THAT I HAD ENSURE THAT THERE WAS A U-TURN SIGN AND I HAD KEPT ONTO MY RIGHTFLT LANE AT ALL TIMES, AND IT WAS VEH B WHO HAD SWERVED ONTO MY LANE THUS CAUSING THIS ACCIDENT. MOREOVER, MY SIX YEAR OLD SON IS SEATED ON THE CHILD BOOSTER WHICH IS ON THE LEFT (IMPACT SIDE) OF MY VEHICLE.
