Circumstances of Accident

REFER TO POLICE REPORT NO:T/20180819/2059 LODGED AT PASIR RIS N.P.C. ON 18/08/2018 AT ABOUT 3.35PM, I WAS ON MY MOTORCYCLE AND RIDING ALONG LANE 1, TRAVELLING AT A SPEED OF ABOUT 30-40 KM/HR. AS THE TRAFFIC WAS HEAVY AND SLOW, I DID NOT RIDE AT A FAST SPEED. MY MOTORCYCLE CAME TO A STOP AT ONE JUNCTURE ALONG THE ROAD AND WHEN I STARTED MOVING OFF AGAIN AFTER A FEW METERS, A TAXI FROM LANE 2 CUT INTO MY LANE ABRUPTLY. DUE TO THE SUDDEN LANE INTERVENTION, I DID NOT HAVE TIME TO REACT AND THE LEFT SIDE OF MY HANDLE BAR HIT ONTO THE RIGHT SIDE MIRROR OF THE TAXI, CAUSING MY MOTORCYCLE LOSE BALANCE AND EVENTUALLY FELL TOWARDS THE GROUND. I WAS ALREADY ON THE GROUND WHEN SOME OTHER ROAD USERS CAME BY TO HELP ME UP TO THE SIDE OF THE ROAD. THE AMBULANCE ARRIVED AT THE ACCIDENT LOCATION SHORTLY AFTER BUT AS I WAS IN A STATE OF SHOCK AND COULD NO FEEL ANYTHING AT THAT POINT OF TIME, I WAS NOT CONVEYED TO THE HOSPITAL. I THEN EXCHANGED PARTICULARS AND CONTACT DETAILS WITH THE TAXI DRIVER AND CONTINUED RIDING HOME. IT WAS ONLY AFTER I REACHED HOME THAT I FELT THE PAIN IN MY LIMBS AND BODY. I THEN PROCEEDED TO TAN TOCK SENG HOSPITAL ON MY OWN FOR A MEDICAL CHECK AT ABOUT 6.10PM ON THE SAME DAY THEREAFTER.

Brief Details.

On 18/08/2018 at about 3.35pm, I was on my motorcycle and riding along Lane 1, travelling at a speed of about 30-40km/hr. As the traffic was heavy and slow, I did not ride at a fast speed. My motorcycle came to a stop at one juncture along the road and when I started moving off again after a few meters, a taxi from Lane 2 cut onto my lane abruptly. Due to the sudden lane intervention, I did not have time to react and the left side of my handle bar hit onto the right side mirror of the taxi, causing my motorcycle to lose balance and eventually fell towards the ground. I was already on the ground when some other road users came by to help me up to the side of the road. The ambulance arrived at the accident location shortly after but as I was in a state of shock and could not feel anything at that point of time, I was not conveyed to the hospital. I then exchanged particulars and contact details with the taxi driver and continued riding home. It was only after I reached home that I felt the pain in my limbs and body. I then proceeded to Tan Tock Seng Hospital on my own for a medical check at about 6.10pm on the same day thereafter.
